To the Honorable Town Council of the Town of Bristol: The undersigned hereby respectfully requested of your Honorable Body that:

You will approve the re-striping of the parking spaces on the east side of High Street between Congregational Street and Bradford Street in front of the First Congregational Church property at 300 High Street. In addition to the striping, please re-stencil the handicap symbol on each of the spaces where the handicap signs are placed and re-stencil "NO PARKING" in the space in front of the walkway apron to the church grounds. Finally place a "No Parking Anytime" sign on a post just to the south of the apron.

It is hoped that these markings will be repainted, in the future, as necessary.


