## APPEAL OF ZONING ENFORCEMENT ACTION

### Statement of Appeal Regarding October 23, 2025 Notice of Violation

This appeal is submitted in response to a Town of Bristol's zoning violation notice alleging unlawful parking of landscaping trucks and related materials on the subject property located within a Limited Business zone. Joseph A. Perry respectfully asserts that the use of the property constitutes a legally protected preexisting nonconforming use and requests that the violation be rescinded.

#### Factual Background

- The property has continuously operated as the headquarters for a landscaping business—a use predating current and previous zoning restrictions. The landscaping and nursery business was started in 1948.
- Perry's Nurseries, Inc. was incorporated on September 02, 1964. Joseph Perry began scaling back his landscaping and nursery business but continued to maintain ownership and continued use by leasing the premises to similar business.
- Use of the premises has remained consistent: parking of landscaping trucks, storage of mulch, and business-related activities. There has been no material expansion or intensification beyond the historic scope established before subsequent zoning amendments.
- The transfer of operational responsibility by way of leasing did not interrupt business activity or change the character of the use.

#### Legal Analysis

##### I. Preexisting Nonconforming Use

- The existing lawful use was established prior to adoption or amendment of zoning ordinances that subsequently restricted by such ordinance.
- Rhode Island law and Bristol ordinances protect preexisting nonconforming uses, permitting their continuance so long as the use is not abandoned or unlawfully expanded.
- The landscaping business and associated truck parking began before the imposition of use restrictions on contract construction services or related business types in the Limited Business zone.

##### II. No Abandonment

- Abandonment of a nonconforming use requires both an overt act and intent to relinquish the use.
- Rhode Island statutes and local ordinances establish that mere changes in lessee, business management, or temporary reduction in activity do not constitute abandonment provided intent to continue is demonstrated and the character of the use is preserved.
- The continued leasing of the property for essentially the same business purpose preserves the nonconforming use. There is no evidence of a voluntary cessation exceeding the statutory presumption of abandonment.

### III. No Expansion or Intensification

- The current truck parking, storage of mulch, and continued landscaping business conform to the historic use pattern. There is no evidence of increased vehicle traffic, enlarged storage areas, or other activity exceeding what existed under the original owner.
- Leasing the property for similar landscaping purposes does not constitute expansion or change of use; it is a continuation of the protected nonconforming activity per Rhode Island precedents.


#### Request for Relief

Based on the foregoing, the owner respectfully requests:

1. Immediate withdrawal of the notice of violation.
2. Official recognition of the property's use as a legal preexisting nonconforming use for landscaping and associated business vehicle parking and storage.
3. Preservation of the right to lease the property for identical business operations, consistent with established Rhode Island law.
4. If the zoning board contests any element, a public hearing to introduce evidence substantiating uninterrupted historic use and address any claims of expansion or abandonment.



Dear Mr. Perry,

Please be advised that the Town of Bristol (the "Town") has determined that your above-referenced property (the "Property") is in violation of the Zoning Ordinance. Specifically, it appears that vehicles from three (3) different contract construction service businesses are being parked on the Property, including four (4) oil trucks from Levi's Oil Company, three (3) trucks from American Tree Works and three (3) trucks and trailers from Pineridge Landscaping Company. The parking of these vehicles on the Property constitutes the use by contract construction service businesses which are prohibited within the Limited Business (LB) zoning district. Accordingly, you are hereby directed to bring the Property into compliance by removing the vehicles on or before November 12, 2025 (hereinafter the 'compliance date').:

In the event that this violation is not corrected or a timely appeal has not been filed by the compliance date, we will have no choice but to assess a fine in accordance with R.I. Gen. Laws § 45-24-60(a) and Sec. 28-407 of the Zoning Ordinance. The Town may then choose to pursue this matter in the Municipal Court, at which time we will seek an order compelling you to comply with the Zoning Ordinance, in addition to fines for failure to comply.




