
Sweeney/Teixeira- Voted unanimously to refer to the solicitor to prepare an ordinance amendment to increase the number of BVl (limited) liquor licenses by one; and call for public hearing.

Prior to the vote taken, the petitioner Brian Dwiggins of 144 Whipple Road, Smithfield, RI spoke on behalf of the request. Mr. Dwiggins apologized for his absence at the September 29, 2021 council meeting. He explained to the council that he and his wife, and partner in the business, were eager to grow and evolve their business. Mr. Dwiggins explained to the council that they currently operate a café in Riverside and he provided the council with a history of their establishment.

Mr. Dwiggins noted that they were looking to add craft cocktails and create a space that would be a catalyst for the community.

Mrs. Jess Dwiggins of 144 Whipple Road, Smithfield, RI also spoke on behalf of the request. She explained that they were looking to create a space that would allow for open mic nights, game nights, weekend brunches, and a space where people can go for a dessert and after dinner drink.

Mr. Dwiggins noted that based on prior experience, the establishment for selling coffee, and no liquor, was not



sustainable after 3pm. He stated that they didn't want to be closing the café at a time the other establishments in Unity Park were opening.

Mrs. Jess Dwiggins stated that they were in previous negotiations with the town of Warren and had plans of opening their new business in Warren. She said that the developer of Unity Park, Mr. Joseph Brito, had reached out to them to consider opening their establishment in Bristol.

Vice Chairwoman Parella stated that she thought the concept was a "great Idea". She stated that the town looked forward to Unity Park becoming successful; and that it was a big win to have the establishment located in Bristol.

Councilman Ley stated that he had recently visited the Borealis Coffee shop in Riverside; and that he would be in support of the petition based on the recommendations and the closing time of 10pm.

Councilman Sweeney stated that he was excited about the culture of the business and launching it in the Unity Park Development. He stated it would be an economic driver and is in support of granting a full liquor license.

Councilman Teixeira stated that he had recently walked around Unity Park. He explained that there was a recent creation of a full liquor license in the development that had not opened yet. He stated that he would have an issue with granting another full liquor license upfront without understanding the impact on the surrounding neighborhood.

Vice Chairwoman Parella stated that the consideration made for Borealis Coffee may set pertinence to other coffee shops looking to do the same. She asked the petitioners if it would be feasible for the business to start off with a limited liquor license.

Mrs. Jess Dwiggins responded that they didn't want to miss out on the synergy of the distillery opening next door; and that their intent was to capture their clientele right at the beginning and avoid not making a good first impression.

Chairman Calouro stated that he could not support a full liquor license request at this time; however, he would agree to a limited liquor license. He explained that it had been the town's past practice to issue a limited, beer and wine, license with a

review in six months before considering a full liquor license. He stated that there were two establishments set to open with liquor licenses and a brewery. He explained that he would have to consider the impact that would have on the neighborhood before considering another full liquor license.

Developer Joseph Brito of 161 Poppasquash Road addressed the council. Mr. Brito explained that he understood the notion that the first impression was always the best impression. He also understood the council's authority to issue a limited liquor license with a review in six months before considering a full liquor license. He asked that the council may consider reversing the process and issuing a full liquor license first and then review in six months, based on all the positive recommendations.

Mr. Brito noted that he was concerned that the business may lose momentum and that he wanted to ensure customers returned.

Mr. Brito asked the council to consider the value of the development of Unity Park on the surrounding neighborhoods. He explained that the improvements made in Unity Park have also increased the value of homes in the neighborhood.

Councilman Ley stated that he was aware of the concerns of the surrounding neighborhood; however he noted that since the request for a Full liquor License would require a public hearing, the neighbors would essentially have an opportunity to voice their opinions. He suggested that the council consider full liquor licenses requests on a case by case basis.

Councilman Sweeney noted the business would bring value to Bristol and he would hate to lose a good business to another town.

Assistant Solicitor Teitz explained that there is no written policy on issuing a limited license with a six month review period before considering a full license. He noted that it has been past practice and it is per the council's discretion. He also noted that the process for rescinding a liquor license is not an easy process.

Chairman Calouro said that he wanted to be fair and consistent and that he wanted to be courteous of the surrounding neighbors.




