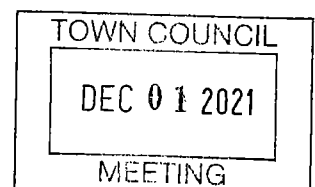

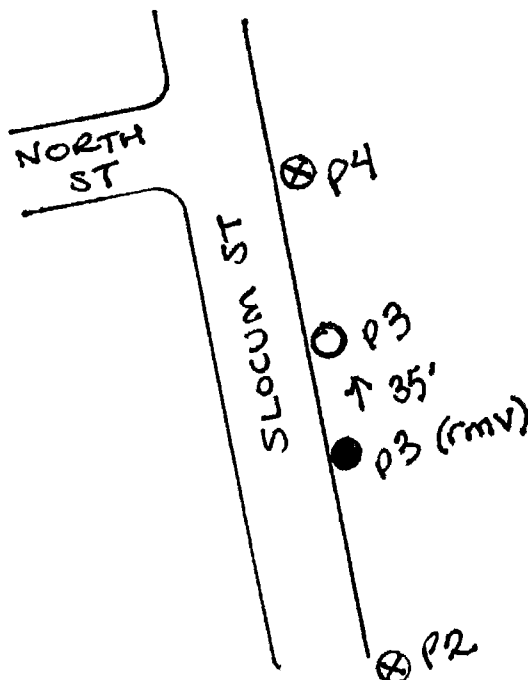

JOINT POLE LOCATION P3 SLOCUM ST

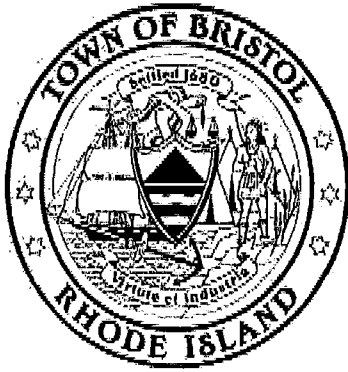
