Sir,

Brian Dwiggins dba Borealis Coffee Company LLC is requesting a Class BV liquor license for his establishment located at 500 Wood St, unit number 113. If approved this establishment will be set up as a coffee café with an alcohol serving area at the bar. The alcohol serving area will have different hours of operation than the coffee café. This location has ample parking in front of the business and additional parking available on the property. Construction will begin shortly and is scheduled be completed by January 2022. Listed below are the requested hours of operation for both the coffee café and the alcohol serving area:

### Coffee Café hours of operation are as follows:

- Monday through Friday 6:00am to 10:00pm
- Saturday 7:00am to 10:00pm
- Sunday 7:00am to 8:00pm

### The requested bar hours of operation are as follows:

- Monday through Friday 2:00pm to 10pm
- Saturday through Sunday 10am to 10pm

I have spoken to Brian Dwiggins and reviewed the petition request. There is no known reason for denial of a Class BV liquor license provided that all Law and Ordinances governing this practice are followed. If a Class BV liquor license is added and approved by the Town Council, I do recommend a 6-month review be conducted of the establishment.




Borealis Coffee, 500 Wood St. unit 113 (front view)






