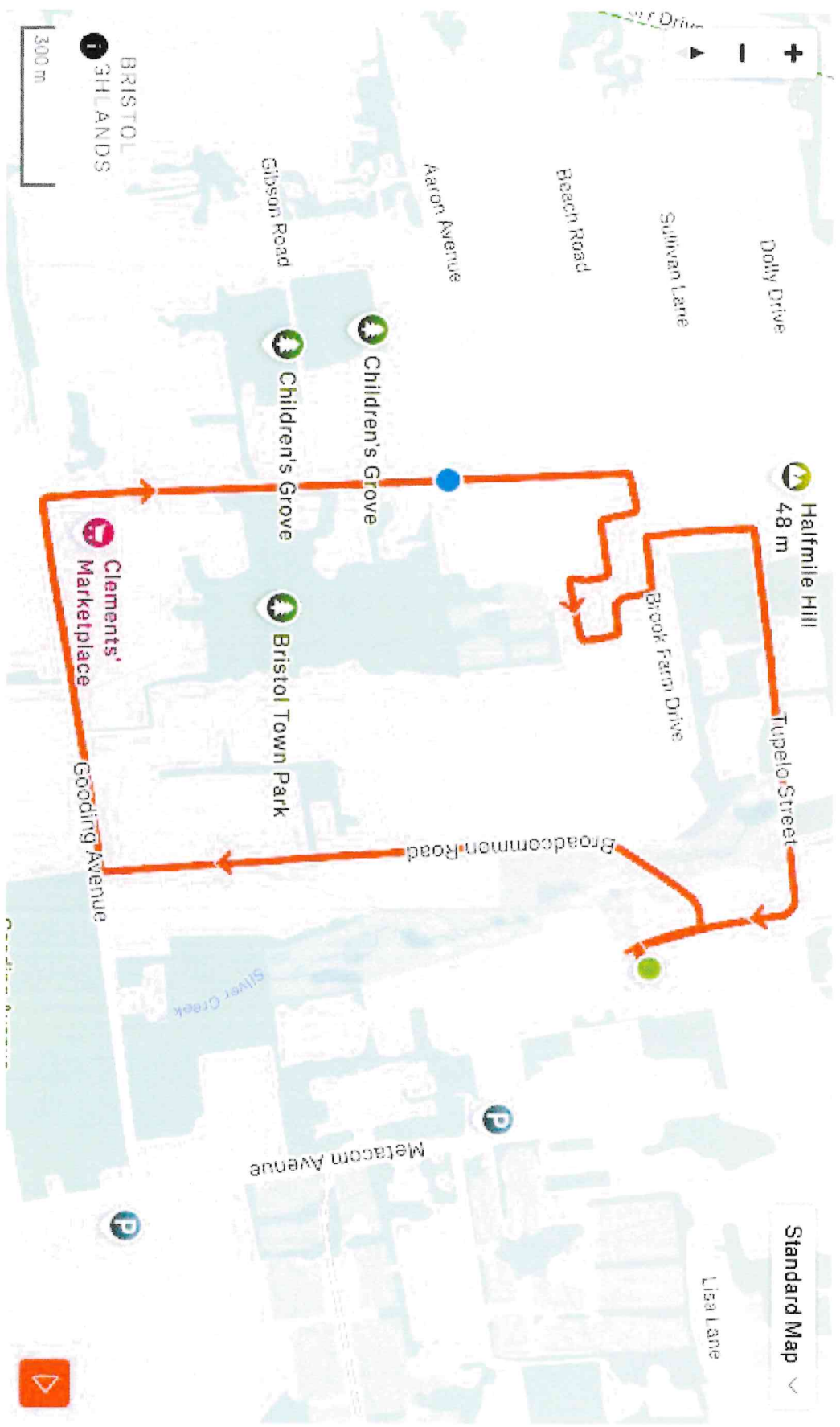
Honorable Town Council of the Town of Bristol:
