### NARRATIVE / GIST



On 3/19/26 at approximately 1402 hours, Nicole Amesbury [REDACTED] responded to Police Headquarters to file a damage to property complaint. I spoke with Amesbury in the lobby of HQ.

Amesbury advised she is the landlord of 48 Cottage St and on 3/7/26 her tenant informed her that the concrete wall in front of the residence was damaged by the Town when clearing the sidewalks after the blizzard on 2/22/26. Amesbury advised no one witnessed the incident but there was no visible damage prior to the storm/clean up. Amesbury stated it took several weeks to file the complaint because she did not know she needed a police report and was waiting to hear back from DPW which took some time. Amesbury advised she was waiting for a contractor to provide an estimate for the repair.

Amesbury provided photographed of the damaged wall which I attached to this report.

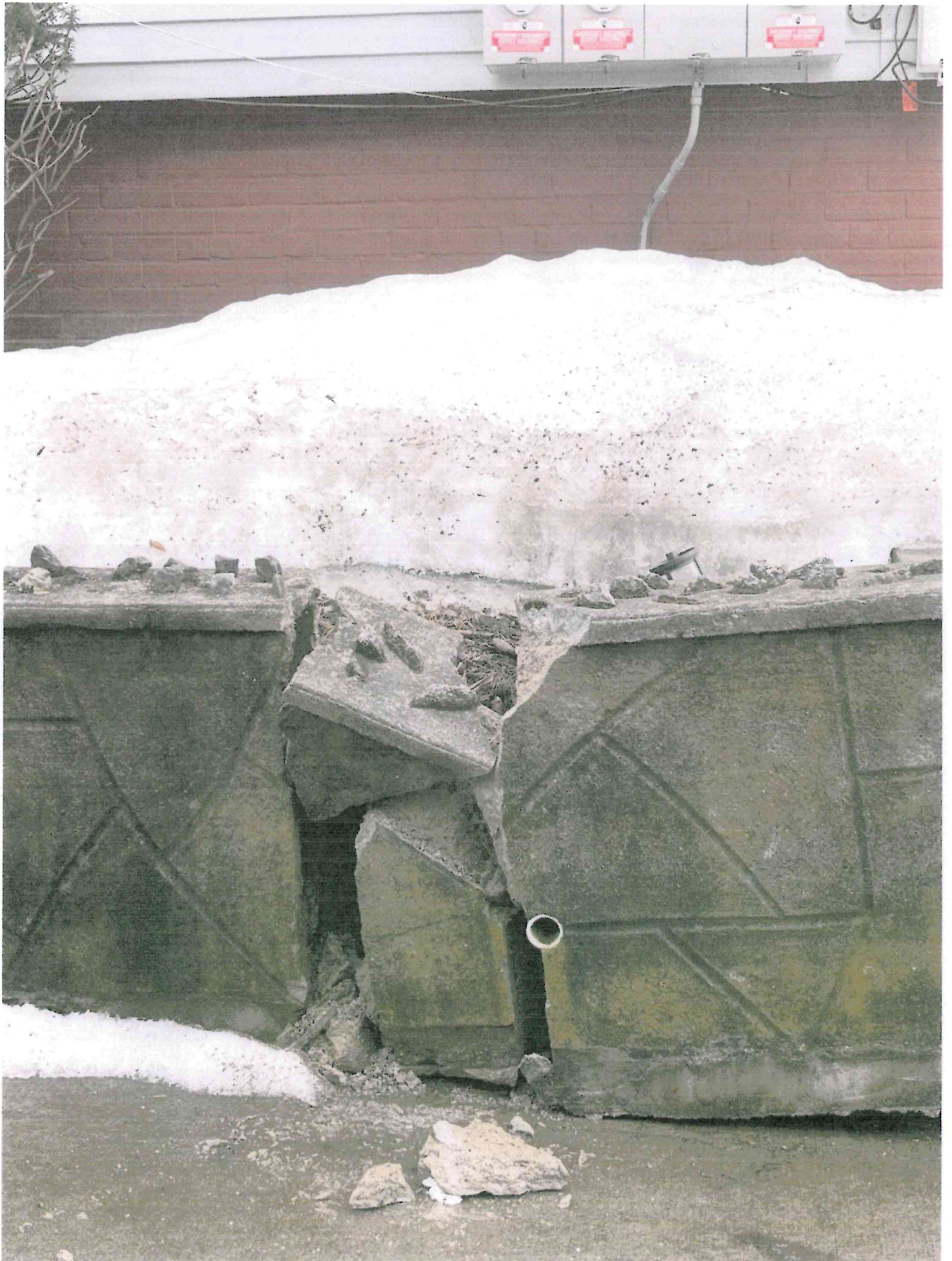
