Marina Parking Lot Off Season & Fee for Ferry Commuters

The Prudence Island residents are appreciative of the use of renting parking spaces in the marina parking lot off season, however for many islanders the \$150/month cost is a financial hardship, especially for the commuting workforce and senior residents who need to mainland access for medical and important personal needs. Last season not all the spaces were rented because the high cost was not affordable.

- For your consideration we ask that there be an adjustment of the monthly cost of the Off-Season parking from \$150 per month to \$75 per month.
- The program is currently 4 months December – March. We also ask that the winter season be extend to 5 months, because the off season runs from November 16th – April 14th.

Marina Parking Lot "Drop off" for Ferry Commuters

There have been several ferry passengers who drive into the ferry parking lot to unload at the ferry office window or onto the ferry and within a few minutes return to their car with a \$30 parking ticket.

- Request to allow ferry passengers to place a "Drop Off" sign on their dashboard or turn on the car emergency flashers while they are at the ferry office window or unloading at the ferry dock, so the Harbor Officers know the intention is to not to illegally park and the vehicle would not be ticketed.
