This is to inform you that the above- mentioned Town- owned parcel is being declared surplus and offered for sale. As the abutting property owners to this strip of land, the Town is offering it to you for purchase subject to a public hearing and Town Council approval.

The terms of the offer are as follows:

1. The minimum sale price is \$1,200 which is based on the Tax Assessor's current property assessment, but if more than one of you express interest, it will be sold by sealed bid;
2. The purchaser will be responsible to pay for the cost of the public hearing notice;
3. The purchaser will be responsible to pay for preparation of the deed;
4. The purchaser will be responsible to merge the parcel into their lot with the Tax Assessor's Office.




