Second page to Bristol Merchants Association Road closure review:

The Merchant's Association is requesting a road closer of State Street between Hope Street and Thames Street to hold a Holiday Fair December 6th from 10am until 4pm.

Due to the road closer and consideration for the number of pedestrian traffic for this type of event, a detail officer with a vehicle is required to block off State Street at Hope Street and assist with pedestrian traffic crossing at this location. This detail officer will need to be scheduled to start when the road is blocked off for set up and remain at this location until all items are removed from the roadway and reopened for motor vehicle traffic. The Merchants association will be responsible for requesting and payment for this detail officer and vehicle.

Additionally, State Street at Thames Street will need to be blocked off to motor vehicle traffic with the use of concrete barriers or stationary vehicle/ heavy equipment to prevent a motor vehicle from entering this pedestrian-filled event.

Vendors for the event should be notified to have all items removed from the roadway by 4:30. The detail officer will assist vendors with clearing and reopening the roadway as quickly as possible.

After reviewing this petition, there is no known reason to deny the approval of this Road Closure, provided that all laws and ordinances governing this practice are followed.
