NARRATIVE / GIST



On 04/02/2026 at approximately 2040 hours I was dispatched to 5 Massasoit for report of property damage sustained during the cleanup of Blizzard Hernando.

Upon arrival I activated my body worn camera and met with David Pacheco [REDACTED]. Pacheco escorted me to the location of the damage, at which time I observed a retaining wall built using 4" x 4" x 8' pieces of lumber. Two pieces of lumber located at the end of the wall which borders Massasoit Ave had been hit reportedly by a plow according to Pacheco.

I observed the pieces of wood to be cracked and splintered in the location which they were struck. Pacheco advised he wished to have the incident documented so that he may pursue reimbursement for the damage from the town.

Photographs of the damage have been uploaded into this report. All parties advised incident would be documented.
