

- 2. Power wash clean entire surface of dirt and debris.
- 3. Clean and fill Major cracks Approx. 221 L.F. with nova-caulk crack repair as needed. (Note: Cracks will reappear.)
- 4. Apply Laykold Color System:
 - a.) 2 coats of acrylic re-surfacer.
 - b.) 1 coat of (sand) any standard colors. (Burgandy)
 - c.) 1 coat of (top) any standard colors. (Burgandy)
 - d.) Layout to regulation, tape and hand paint lines with two coats of White acrylic line paint.
