

RESOLUTION

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, AUTHORIZING IN-KIND SPONSORSHIPS OF CERTAIN PUBLIC EVENTS TAKING PLACE IN CALENDAR YEAR 2024 IN ACCORDANCE WITH CHAPTER 70 “STREETS, SIDEWALKS, AND PUBLIC PLACES” OF THE CITY OF BURLESON CODE OF ORDINANCES.

WHEREAS, the City of Burleson, Texas (“City”), is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, Chapter 70 “Streets, Sidewalks, and Public Places” of the City of Burleson Code of Ordinances requires that the City Council approve public events that request resources of at least five hundred dollars (such as the cost of policing the event, cost of providing medical services, cost of public works services, cost of parks and recreation services, and waiver of building rental fees) from the City; and

WHEREAS, there are eleven different public events or rentals for calendar year 2024 that are requesting in-kind sponsorship of over five hundred dollars, the list of events and additional information being more specifically described in Exhibit “A”, attached hereto and incorporated herein by reference for all purposes (the “Public Events”); and

WHEREAS, the City Council has reviewed the Public Events and desires to approve the sponsorship of the Public Events in accordance with Chapter 70 of the Code of Ordinances; and

WHEREAS, the City Council finds that the sponsorship of the Public Events is in the best interest of the citizens of the municipality, is for a public purpose, is for the good government, peace, and order of the municipality, and is for the trade and commerce of the municipality.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, THAT:

Section 1.

The City Council hereby approves the sponsorship of the Public Events in accordance with Article V “Public Events” of Chapter 70 “Streets, Sidewalks, and Public Places” of the Code of Ordinances. The Public Events shall be required to meet all of the other requirements of Article V of Chapter 70 of the City of Burleson Code of Ordinances.

Section 2.

This resolution shall take effect immediately from and after its passage.
