SUBJECT:

Consider and take possible action on a resolution supporting entering into the First Amendment to the Advance Funding Agreement (AFA) with the Texas Department of Transportation (TxDOT) for Local Government Maintenance of Railroad Pavement Markings and Signs (Off-System) and authorize the City Manager to sign on behalf of the City. SUMMARY:

On April 21, 2025 City Council approved a Resolution authorizing the execution of an AFA with the TxDOT for Local Government Maintenance of Railroad Pavement Markings and Signs (Off-System). TxDOT has since identified one additional location that was not included in the original AFA and desires to amend the AFA. This item includes adopting a resolution supporting entering into the AFA Amendment.

TxDOT identified several at-grade railroad crossings that required additional roadway signage and pavement markings to meet applicable safety standards. TxDOT secured Section 130 Federal funding that is intended to improve at grade crossings. TxDOT will fund and manage the project in its entirety. The City of Burleson will assume ownership of the improvements and need to agree to maintain the improvements made with the project. The following railroad crossings will be upgraded:

- Alsbury Blvd between Candler St. and Hulen St. (DOT 020664T)
- Commerce St. connector between Wilshire Blvd and Commerce St. (DOT 415970E)
- Renfro St. between Commerce St. and Main St. (DOT 415972T)
- Ellison St. between Commerce St. and Main St. (DOT 415973T)
- Eldred St. between Commerce St. and Main St. (DOT 415974G)
- Alsbury Blvd between Commercial Blvd. and N Burleson Blvd. (DOT 414400N)
