SUBJECT:

Consider and take possible action on a Cooperative Purchasing Agreement with Austin Mac Haik Ford Lincoln, LTD through the BuyBoard Cooperative (Contract # 724-23) for purchase of six (6) light duty trucks in the amount of \$260,995.50. (Staff Contact: Errick Thompson, Director of Public Works)

SUMMARY:

This item includes the purchase of two replacements funded in the Governmental Equipment Replacement Fund for FY25. These units support daily service delivery in Code Enforcement and Environmental Services at a combined cost of \$89,710.17.

The item also includes the purchase of three replacements funded in the Proprietary Equipment Replacement Fund for FY26. These units support daily service delivery in Water Operations at a combined cost of \$116,448.58.

Finally, this item includes the purchase of one addition to the fleet funded as part of the August 18, 2025 budget amendment to the Parks Performance Fund. This new addition will support City maintenance of the Bartlett Soccer Complex at a cost of \$54,836.75.
