# BURLESON CITY COUNCIL SPECIAL MEETING AUGUST 11, 2025

#### 3. BUDGET

A. Receive a report, hold a discussion, and provide staff direction on the Fiscal Year 2025-2026 Proposed Budget and related items. (Staff Contact: Tommy Ludwig, City Manager)

City Manager Tommy Ludwig presented the proposed FY 2025-2026 budget, including supplemental requests, fee changes, fund forecasts, capital improvement programs, and departmental financial overviews. The Finance Committee expressed overall support, recommending a tax rate of \$0.7218 (Voter Approval Rate with increment), restoring merit, step increases and Public Safety Equity Adjustments to October 1, 2025, and budgeting three paramedics and one police officer effective January 1, 2026.

During discussion, members expressed concerns with raising the tax rate but were supportive of using the additional funds for roadway maintenance, public safety, and employee pay adjustments. While noting that the tax rate had decreased in the past, the consensus was that the proposed increase is necessary to maintain service levels and address infrastructure needs.

City Council consensus is to adopt \$0.7218 tax rate with increment; implement Merit and Step Pay and Public Safety Equity Adjustments on October 1 (retroactive for General Fund for merit); delay hiring of three paramedics and one police officer until January 1, 2026; all other items funded October 1.

## **RECESS AND BACK TO ORDER**

Mayor Fletcher recessed for a short break at 10:43 a.m. and called the meeting back to order at 11:00 a.m. with all members present.

B. CSO#5875-08-2025, resolution proposing a tax rate for the 2025 tax year with a record vote. (Staff Contact: Kevin Hennessy, Interim Director of Finance)

Harlan Jefferson, Deputy City Manager, explained the purpose of the resolution to the city council.

Motion made by Alexa Boedeker and seconded by Dan McClendon to approve the resolution to give notice of a proposed maximum tax rate for 2025 tax year of \$0.7218 dollars per \$100 value.
