The 6 goals of the parks master plan: 1. Maintain excellent level of service 2. Improve walkability and park access 3. Develop community parks 4. Address aging parks and infrastructure and improve experience 5. Develop premier trail system 6. Develop a CIP When evaluating what projects to prioritize multiple factors are considered. Is this project identified as a priority in the master plan, is it a high priority to the residents, has it been identified by staff to be in need of repair

or replacement. Current projects underway in Fiscal Year 2021: Village Creek Trails Segments 3 & 4, Splash Pad, Dog Park, Prairie Timber Park, Shannon Creek Park, Claudia's Playground, Cindy Park, Fire Station 16 Memorial Garden, Park Annex Facility, Oak Valley Trail Dog Park Connection, Oak Valley Interpretive Signage, and Clark Park. Funding: Funding for capital improvement projects are sourced from 4B, existing bond revenue, park development and dedication fees, and existing unallocated capital funds.
