November 6, 2008 - Adopted current Design Manual and Subdivision & Development Ordinance

HISTORY

CURRENT REGULATIONS ARE OUTDATED

- City policies and standards have changed over the years
- Subdivision Ordinance currently have technical engineering regulations better suited for inclusion in the Design Manual which serves as a guidance document for staff and property owners
- Deviations from technical regulations require City Council approval creates delays for developers and property owners
- Update should provide staff the ability to review various requests using technical expertise and accepted industry standards - variances may be needed due to site conditions and could occur at any time during construction
- City standards are the same for ETJ creates budgetary maintenance issues for the county leaving the property owners potentially responsible for maintenance
- Current regulations included in several different documents making it cumbersome for individual property owners to determine what is required
