

Can handle the traffic – used for COVID vaccinations





HART VERITY SCAN MAY 2, 2026



Hart Intercivic — Verity Scan 2.7 Same used in our last election

- Requires paper ballot and counts at the point of voting
- No hand counting except for mail ballots
- Tarrant County uses the exact same equipment
- Lower to accommodate ADA requirements
- Programmed to comply with new requirements and future requires
- Require establish Central Counting Station



Business Day

•When offices are open for regular business

of Ballots

- Distributed not exceed # of voters
- Need clarification Spoiled

Increase Penalty

- •Class A to 2nd Felony
- Elected Officials 1st Felony

Curbside Voting

- Voter attest cannot physically enter
- Must ask driver if they transported more than 7
- Prohibits loitering or electioneering within 20 feet

Voting Days

- •Removes gap between EV & ED
- •Continuous voting days including Sat/Sun/Holidays


Polling Location & Reporting

- •EV locations must be open ED
- •EV & ED results in one number = "in person"
- •By mail will be separate

- CCS Manager
- Tabulation Supervisor
- Presiding Judge



Signature Verification Committee



Signature Verification Committee (SVC)

Appointments

- At least 5 Members
- Notice of who is appointed must be posted
- Chair

What is a Signature Verification Committee?

A committee charged with comparing signatures of applications and correspondence envelopes for ballot by mail

Check for defect and give notice to applicant allowing them to remedy defect

Work done prior to Early Voting Ballot Board

DO NOT COUNT ANY BALLOTS

SVC is option and must be requested by the Early Voting Clerk

Who establishes and appoints SVC?

The authority who orders the election = city council
