SUBJECT:

Consider and take possible action on a minute order authorizing the rate increase proposed by Waste Connections, Inc., as permitted under the existing contract, effective October 1, 2025. (Staff Contact: Lauren Seay, Deputy Director of Administrative Services)

SUMMARY:

The City of Burleson has contracted solid waste and recycling collection services with Waste Connections, Inc. since 2019. The current agreement, which was renewed in May 2023, extends through September 2029.

Under the terms of the agreement, Waste Connections may request a base rate adjustment no more than once annually, with any approved increase taking effect in October. Proposed rate adjustments must receive City approval, which shall not be unreasonably withheld.

Rate adjustments are calculated based on two components: changes in the Consumer Price Index (CPI) and changes in fuel costs. Both are measured by comparing June of the current year to June of the prior year. The CPI and fuel factors are calculated separately and then combined. The combined percentage is applied to the current base rate to determine the proposed price adjustment.

For the current year, Waste connections initially proposed a base rate increase of 4.28% but, at the request of City staff, agreed to reduce the requested increase to an even 4.00%.
