SUMMARY:

The purpose of this public hearing is to receive comments from the public regarding the proposed establishment of a Stormwater Utility for the City of Burleson and the adoption of a Stormwater Utility Fee.

The Texas Legislature authorizes municipalities to establish and operate stormwater utilities and to assess reasonable fees for stormwater management services under Texas Local Government Code, Chapter 552. The statute authorizes municipalities to fund the planning, construction, operation, maintenance, and replacement of stormwater drainage systems through a dedicated utility supported by user fees.

Stormwater infrastructure is a critical public utility that collects, conveys, and manages rainfall runoff to reduce flooding, protect public and private property, maintain roadways, improve water quality, and ensure compliance with state and federal environmental regulations. Unlike the City's water and wastewater utilities, stormwater services have historically been funded through the General Fund, where they compete with other municipal priorities for limited resources.

Establishing a Stormwater Utility creates a dedicated and sustainable funding source that may only be used for stormwater related purposes. Revenue generated by the utility will support ongoing maintenance and improvements of drainage infrastructure across the city.
