

## **RESOLUTION**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, AMENDING CSO#6017-01-2026 EXHIBIT B, AUTHORIZING IN-KIND SPONSORSHIPS OF CERTAIN EVENTS TAKING PLACE IN CALENDAR YEAR 2026, INCLUDING SPECIFIC PUBLIC EVENTS IN ACCORDANCE WITH CHAPTER 70 “STREETS, SIDEWALKS, AND PUBLIC PLACES” OF THE CITY OF BURLESON CODE OF ORDINANCES.**

**WHEREAS**, the City of Burleson, Texas (“City”), is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

**WHEREAS**, the City Council approved Resolution CSO#6017-01-2026 authorizing five different organizations for calendar year 2026 that are seeking a waiver or reduction of room rental fees and/or staff support of over five hundred dollars that are events generally open to the public but are not Public Events; and

**WHEREAS**, Exhibit “B”, attached hereto and incorporated herein by reference for all purposes (the “Rentals”) shall be amended adding Hope Fellowship Co-Op; and

**WHEREAS**, the City Council finds that the sponsorship of the Public Events and the approval of the Rentals are in the best interest of the citizens of the municipality, is for a public purpose, is for the good government, peace, and order of the municipality, and is for the trade and commerce of the municipality.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, THAT:**

**Section 1.**

The City Council hereby approves the Rental and amends Resolution CSO#6017-01-2026 to add the Rental described in Exhibit B to the list of approved Rentals.

**Section 2.**

This resolution shall take effect immediately from and after its passage.
