Good evening Council Members,

I've been listening to the 4:30 workshop today. I decided not to make my public comment by voice and instead wanted to email you all about an encounter I had with two individuals last Friday at the Crown Park wall. I want to thank all of you for addressing the ordinance re: chalk art/graffiti/tagging. I appreciate and support Council Member Bonnie Carter's suggestion for keeping the chalk art to the Camas Library and developing a future program that does not include Crown Park. With school being closed and parks having been closed, our children do not have many public places to go and play freely. I believe our parks, with playgrounds, should be left neutral zones where kids and families can go without fear of any kind.

Below is my brief description, from my social media post yesterday:

"Friday morning, before I was aware of any of this, I had a very disturbing in-person encounter with two men at the park. I was driving with my kids and passed the park. I saw two men, on ladders, putting "Black Lives Matter" with two fists in front of it, on the top portion of the wall, facing Everett St./Top Burger side. I was concerned as it appeared to be paint from afar because it looked solid compared to chalk, and also questioned their intentions being on a public park, where children play, and intentionally placing their work higher than any person could reach, at 8:45am.

I decided to pull over and called the city office to report what was happening, in case it was paint. I was told to call the police station to have an officer come out and check. I called the station directly, no answer, so I called 311. Before the officer arrived, the two men headed to their cars. I was parked on the side of the street. I had no idea the cars in front of me were theirs until they headed towards them. I decided to take the opportunity to ask them what they were doing, in hopes of gaining understanding of their intentions.

I asked them, "What were you guys doing?"

One of the men completely went off on me for simply asking that. He said, "Having fun. Why are you harassing us? We expected people like you. (laughing at me) We're Camas residents and you're a racist. Fuck off."

I immediately got back in my car, without responding to him. As he drove off, he flipped me off out his window. As my kids watched and heard it all.

I stayed there until an officer came to let them know what had happened and the man's offensive language towards me.

The officer thought it was paint as well from afar, but did discover it was chalk. The officer apologized for the person being so unpleasant to me. Shortly after, the officer called me to explain the city was going to send someone out to wash the wall, since they try to keep the parks a neutral place. I was surprised, impressed, and thankful for the city's response."

I do not believe these two men had good intentions, as their behavior and actions towards me showed. This is an example of why I think it's important that the city and Mayor address this and keep the ordinance for our parks to remain neutral while removing any markings, of any kind, if a complaint is made. Which then leads to the work order and it removed.

I've lived in Camas for over 20 years, as well as live on Everett St. myself. Thank you for the support and thank you to our city employees doing the work to keep our city going.
