To Whom It May Concern:

We are confident that you as the Hearings Examiner will see the risk and potential consequences should you approve the Conditional Use Permit for the property located at 2213 NW 23rd Avenue, Camas, WA to the proposed drug and alcohol addiction center, Discover Recovery Treatment Center.

My husband and I are not opposed to this type of facility, but feel the bigger concern is the location of the proposed site – nestled between Dorothy Fox Elementary School, Dorothy Fox Park and Harvest Community Church.

I have personally had several family members voluntarily admitted to drug and alcohol rehab facilities. These family members "...adult professionals..." per Feldman's description of the clientele deserved a place to heal and rebound, but family or not I completely believe this is not the right location for such a facility.

Should you approve this permit, your decision would negatively impact our community and this decision will pose an imminent risk to our vulnerable children that play and learn within line of hearing and sight of the purposed location. Schools are meant to be a safe place for children to be free from the stressors of the word and to focus on learning and play.

Just a simple search on the internet tells you this is not the right location for Discover Recovery facility. Just last year in a small town in Illinois two men at Forest City Rehab got into an altercation putting one man in the hospital and the other indicted on

Exhibit #138 attempted murder charges. Our children should never have to pass yellow police tape or witness this type of altercation as they walk to or from school or playing at the park.

With the proposed site of this facility being so close to a school the probability of safety issues is too great. Should a client seeking treatment have a mental health episode this behavior could put our children at risk – both physically and/or emotionally. As a parent it is our job to protect our children from harm and provide safety and security. I do not want my daughter to have her learning and play interrupted with a school lockdown because of safety concerns due to a crisis at the drug rehab center. This type of facility does not belong next to a school and park.

Our biggest concern is the specific location for this drug rehab facility. The types of clientele accepted are completely out of anyone's control including the facility themselves. My fear is the unknown and the inability to control the types of clientele seeking treatment at this facility including registered sex offenders or convicted felons. It only takes one incident to affect a child and their family forever. As per https://www.discoverrecovery-camas.com/ FAQs listed on their website, they acknowledge the fact that they have NO control over who they admit including registered sex offenders.

In addition, Discover Recovery does not expect to admit any registered sex offenders to the proposed facility. Unless required by law, Discover Recovery will not admit any registered sex offenders at its facility.

As a licensed Assisted Living Administrator with over 20 years' experience, I have seen my fair share of recovering addicts living in facilities I ran. Many of these residents were unpredictable and at times unmanageable leading to police, fire and ambulance assistance for the safety of my staff and other residents. I have seen theft, property damage and disruption to the daily life of others due to the influences of drugs and alcohol.

We believe the risk of incident is too great to approve this location for the Drug Rehab Facility and would expect the review committee to take these risks into consideration. With brining in this type of facility to our neighborhood I would we expect to see a drop in home values, but our biggest concern is the safety, security and impact this facility would have on our kids and community.

I am not concerned about low-income housing and am a great supporter to those - my questions are focused on the Special Needs, Disabling Behavioral Health and Criminal History section. It sounds like an open door to opening the (highly) unregulated Sober Living Homes.

I came from an area with many of these residences and these states are having major issues with them. As a city I think we should be as proactive as possible in setting up strict guidelines as to where those with criminal history/addiction can set up shop.

I also question the line in the comments section about the CUP III for Discover Recovery that states: L.) Opined that services to assist those with addiction is important but should not be allowed in Camas.

I read through all of the letters and I don't recall seeing that. The vast overriding comments where to the tune of "we understand the importance of these facilities, but feel this particular location is not appropriate." Can you please explain where you came to this conclusion?

The city adopted provisions for "permanent supportive housing" consistent with state law (E2SHB <u>1923.SL</u>). Ordinance 21-004 was adopted by Council on March 1, 2021. The city has not received any applications for "permanent supportive housing" since the effective date of the amended code, and the provisions are not applied retroactively.

The following is the adopted definition:

"Permanent Supportive Housing" means subsidized, leased housing with no limit on of stay, that prioritizes people who need comprehensive support services to retain tenancy and utilizes admissions practices designed to use lower barriers to entry than would be typical for other subsidized or unsubsidized rental housing, especially related to rental history, criminal history, and personal behaviors. Permanent supportive housing is paired with on-site or off-site voluntary services designed to support a person living with a complex and disabling behavioral health or physical health condition who was experiencing homelessness or was at imminent risk of homelessness prior to moving into housing to retain their housing and be a successful tenant in a housing arrangement, improve the residents' health status, and connect the resident of the housing with community-based health care, treatment, or employment services. Permanent supportive housing is subject to all of the rights and responsibilities defined in chapter 59.18 RCW.
