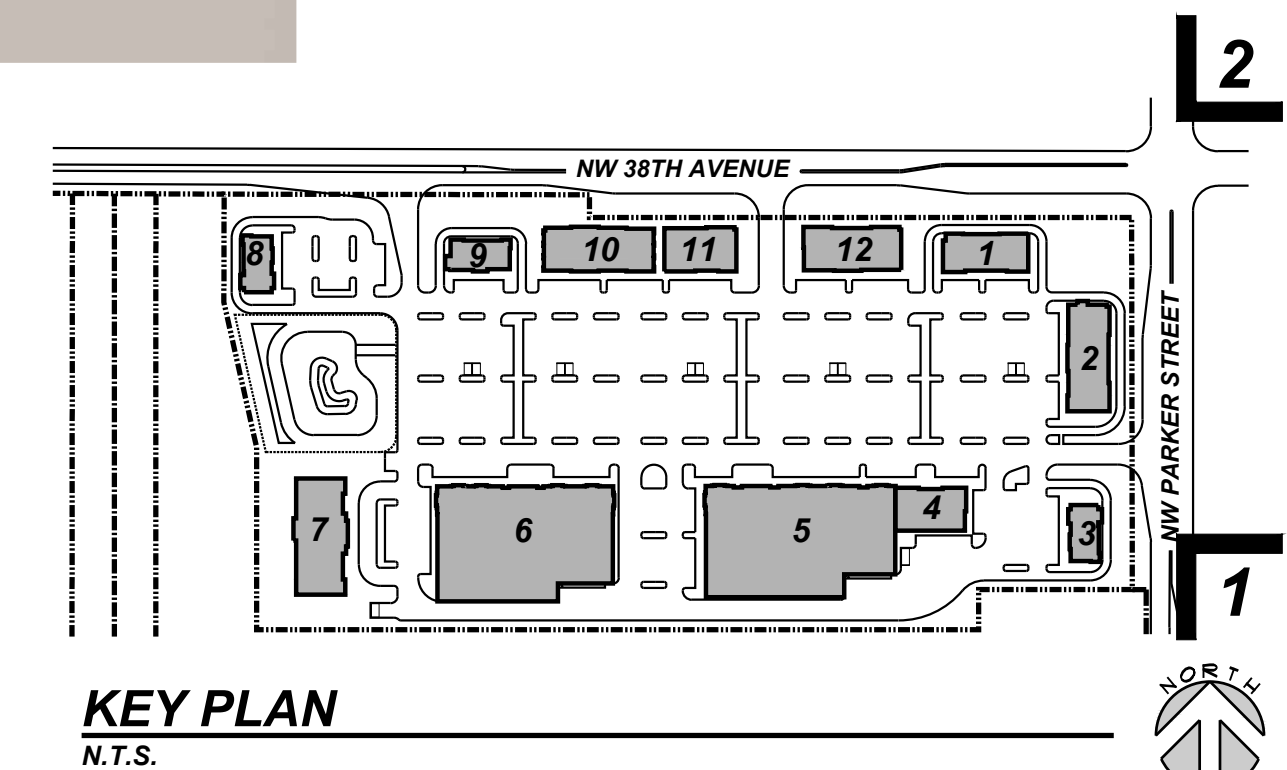

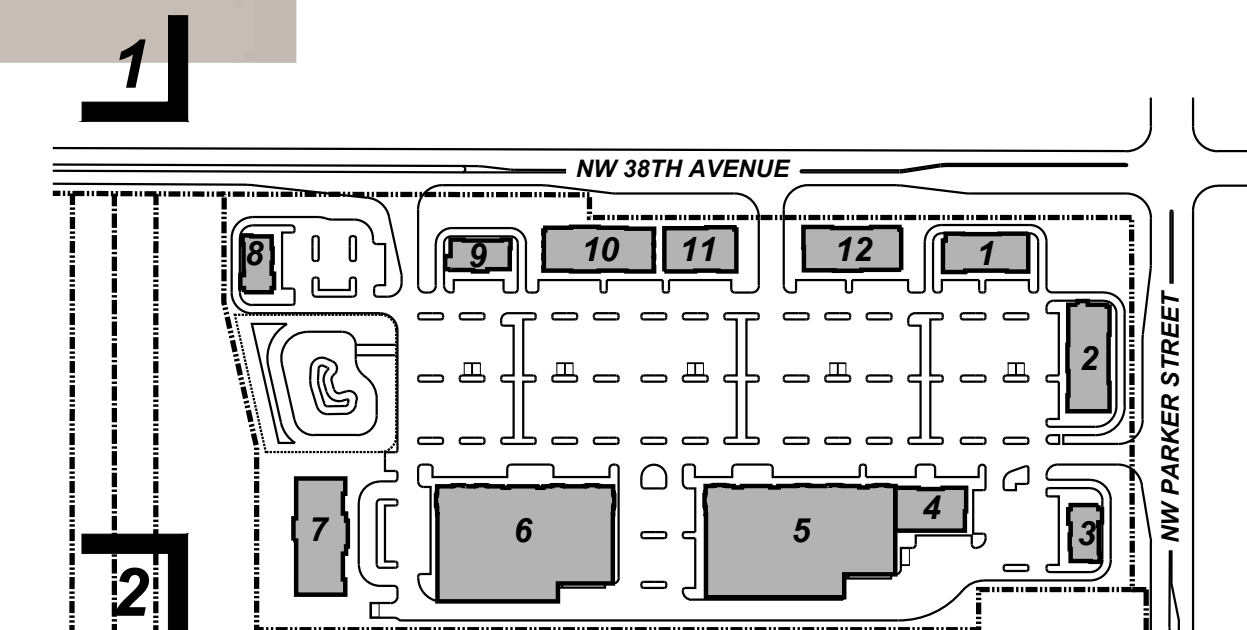

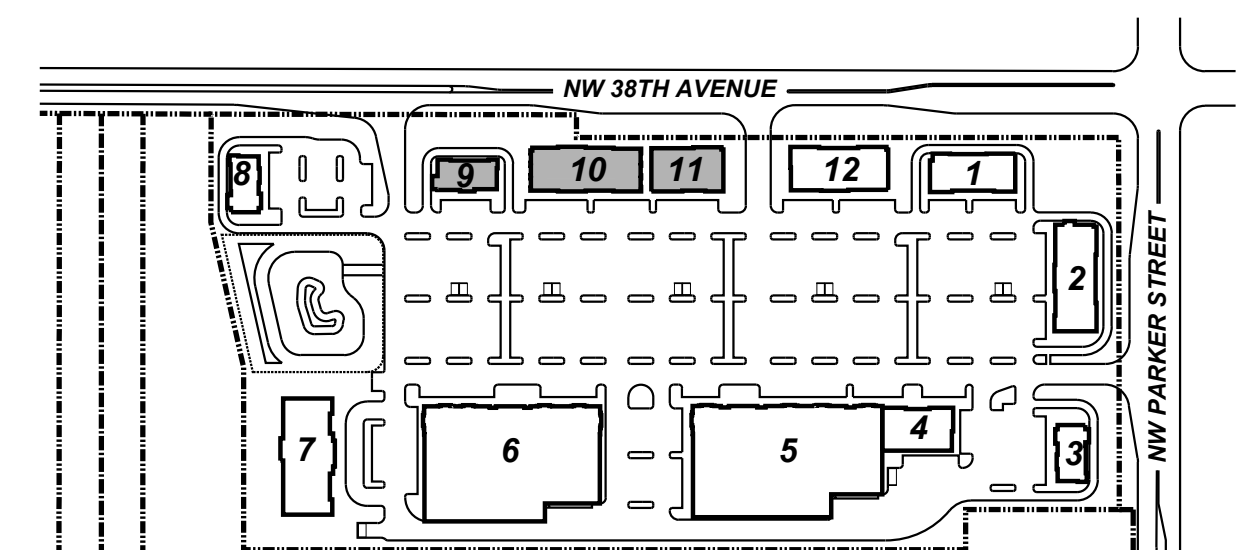

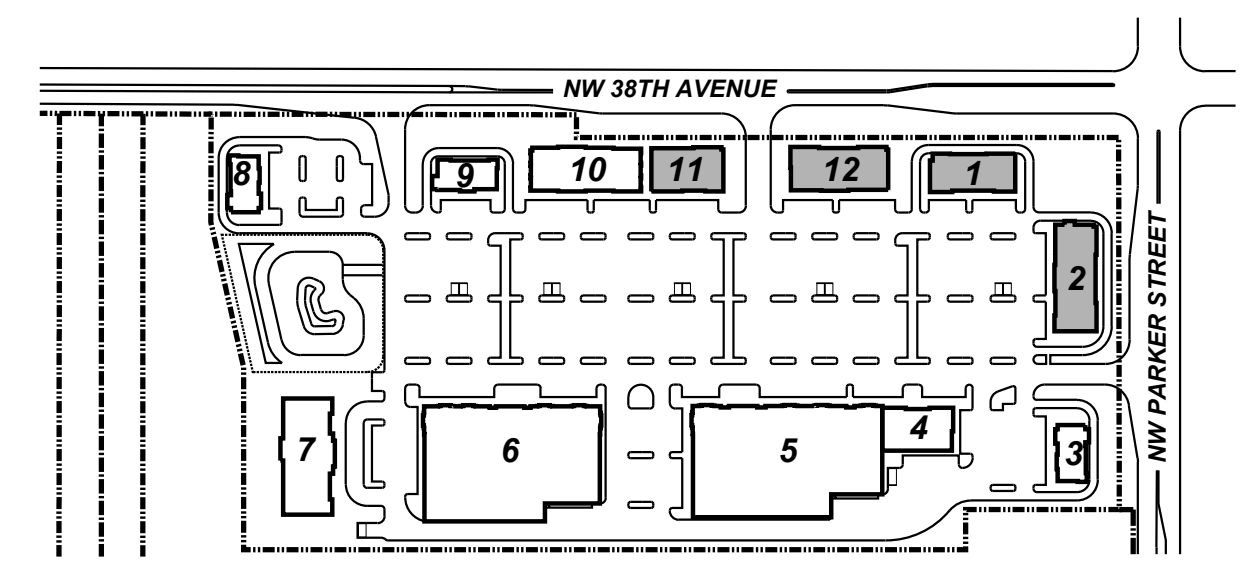

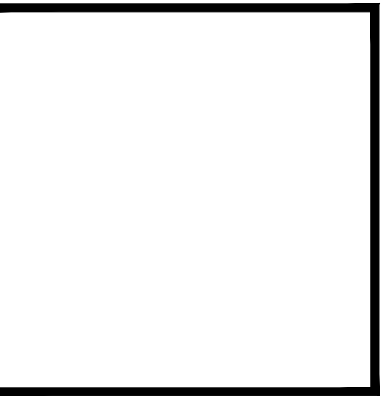
1 SITE BUILDING '5'

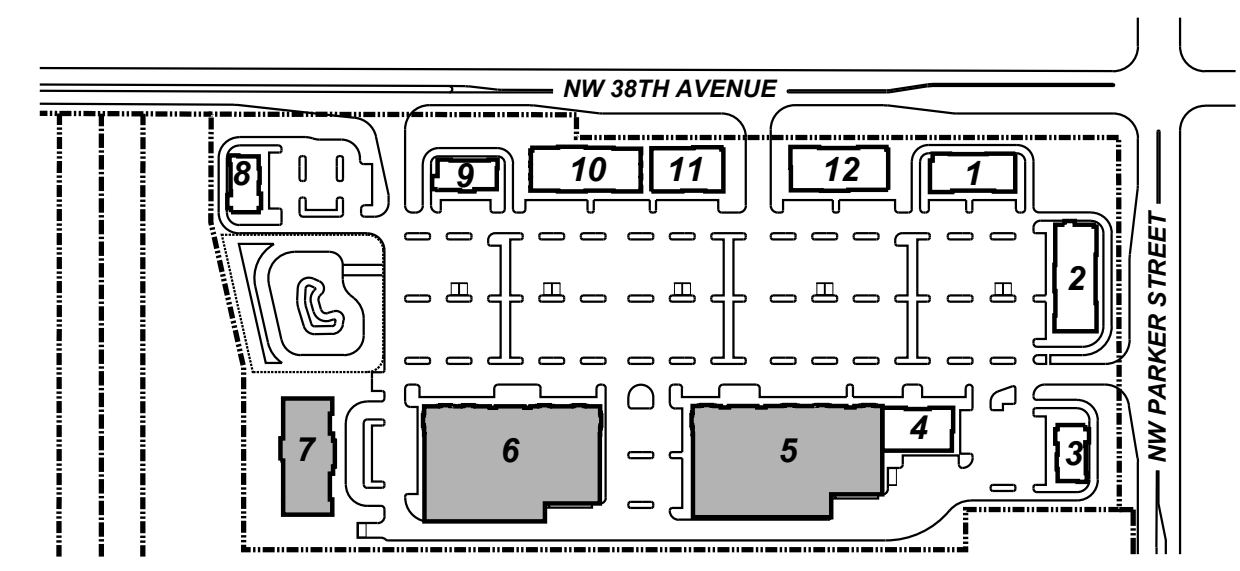

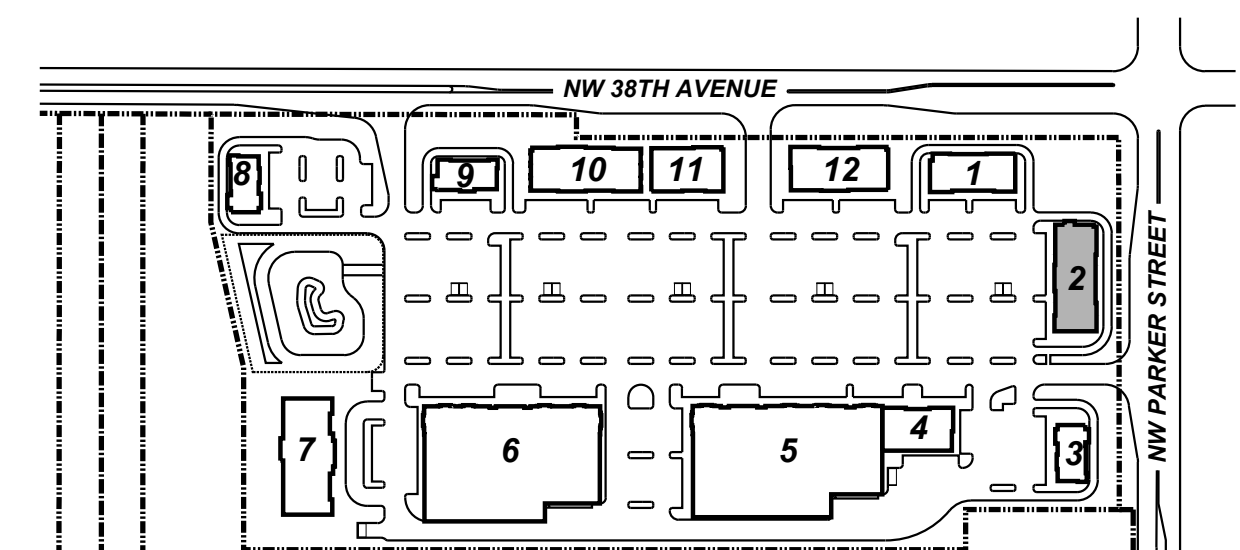

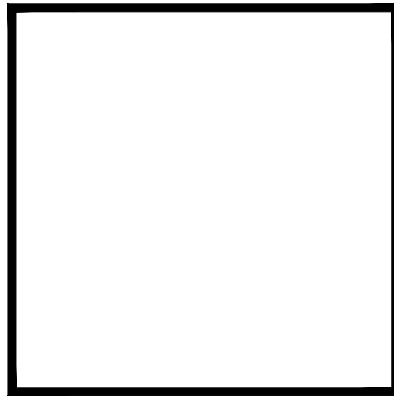
BUILDING '4'

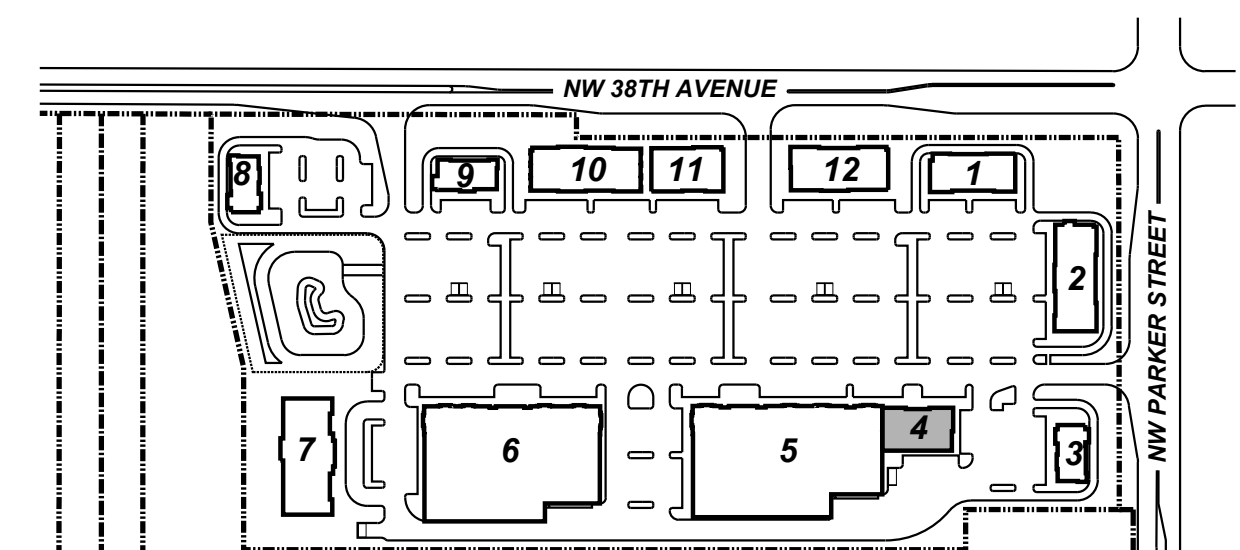

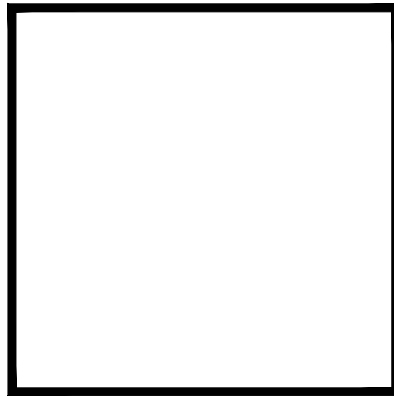

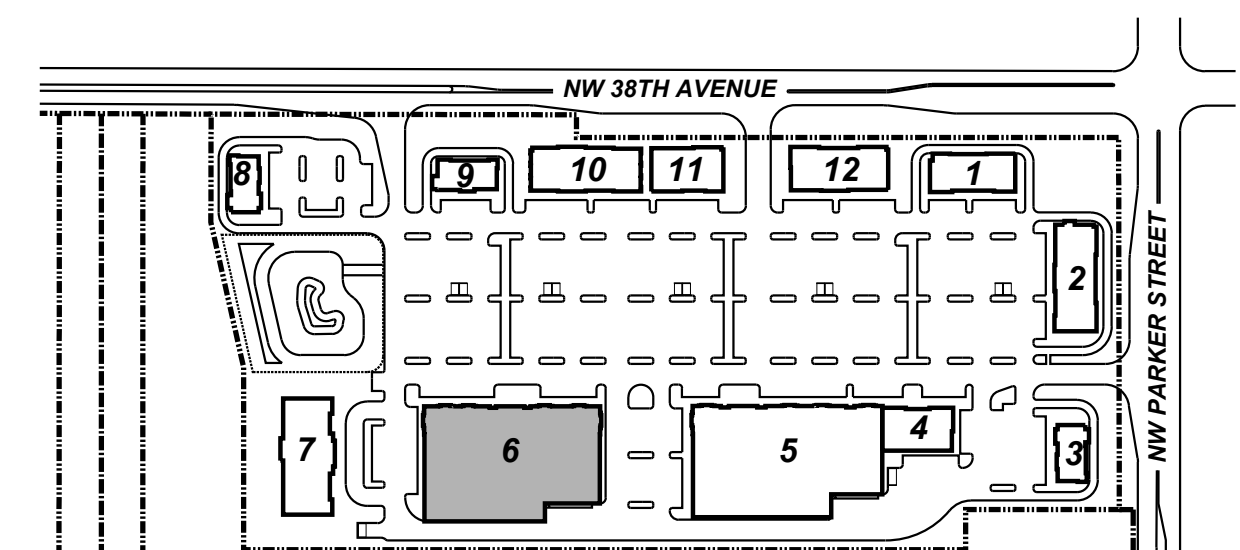


1 BUILDING '6'

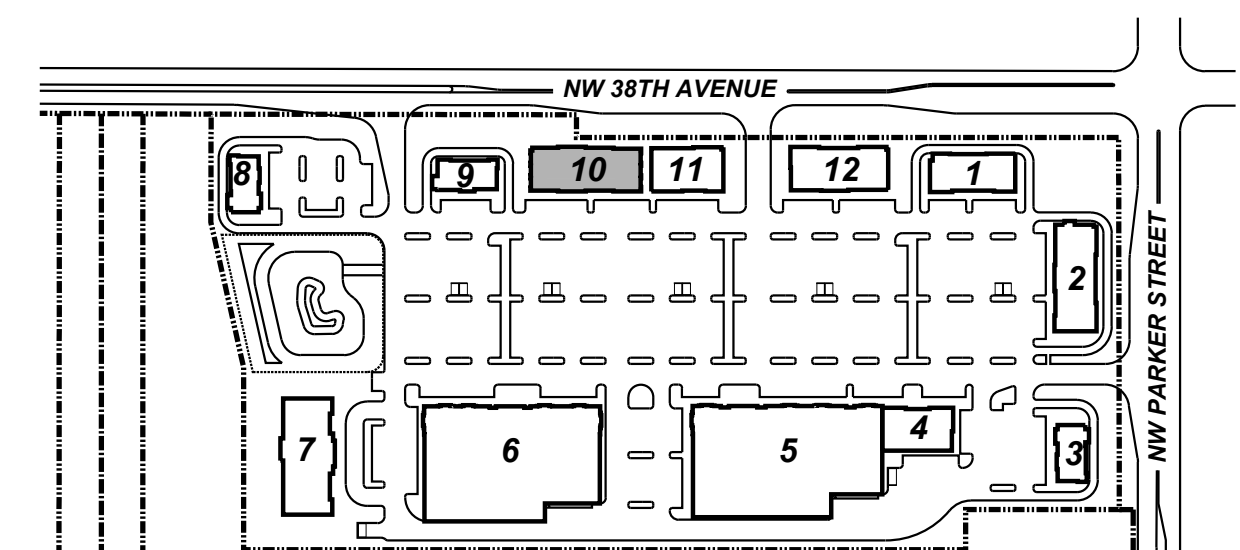
1 **BUILDING '10'**

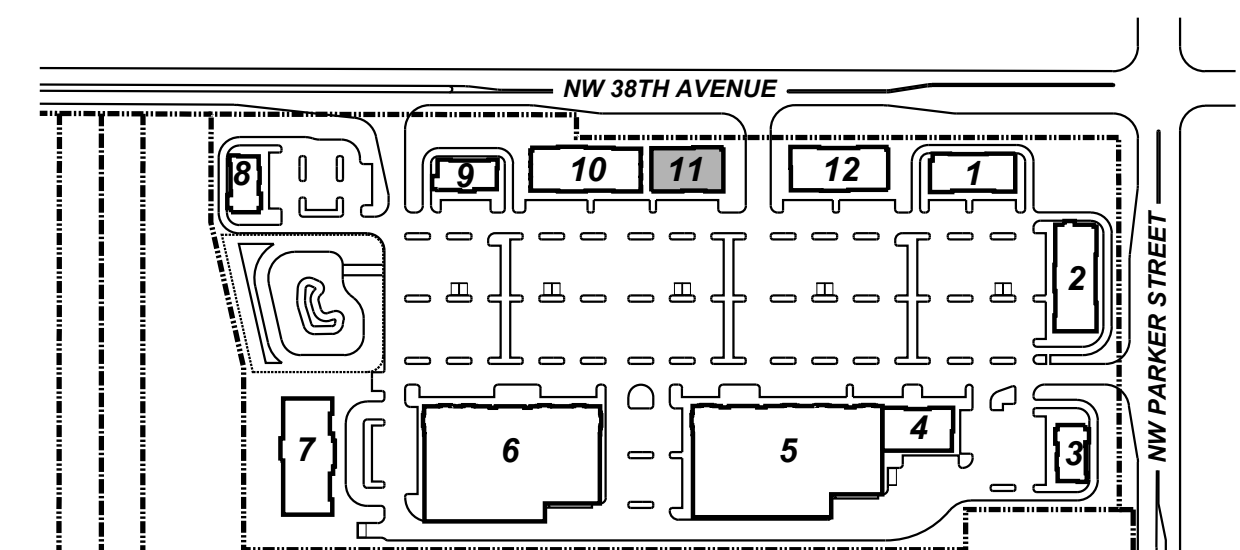

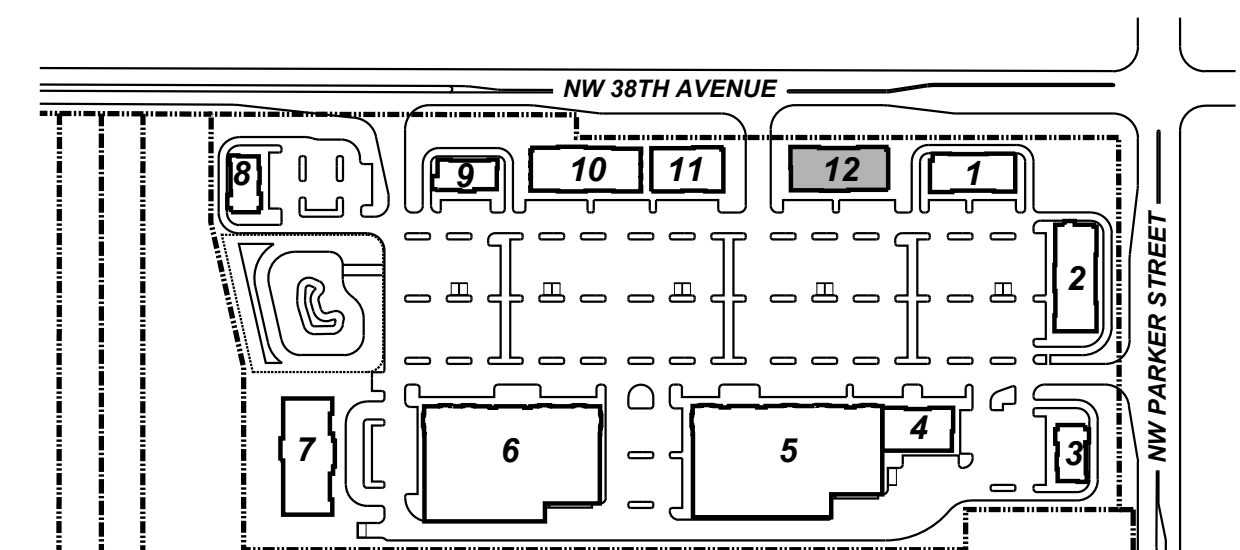
