I am following up on the formal complaint I submitted regarding Councilmember Melinda Orbach's conduct during the April 17, 2025, City Council meeting. As noted, she publicly accused me — by name — of harassment and threatening behavior without evidence, without due process, and without ever attempting to speak with me directly. These remarks, made from the dais and broadcast to the community, initiated a serious and ongoing impact on my personal well-being. I spoke with Captain Ryan for about an hour about the situation, and there was never any complaints filed or investigations conducted. I canvassed with another member of the community who will 100% collaborate with the events that took place, no one seek out where Councilmember Orbach lived, no one asked any neighbors to point out her place of residents.

Since that meeting, the harm has continued. A community member, **David Morris**, (See attached screenshots) has been persistently repeating this false narrative, now labeling me as "the alleged stalker" in public forums. These inflammatory comments, directly tied to the accusations made by Councilmember Orbach, have escalated the reputational harm and further **damaged my mental and emotional health**.

The **cumulative effects** have been significant:

- · Chronic stress and anxiety
- Disrupted sleep and emotional fatigue
- Loss of focus and productivity at work
- A growing sense of **isolation and hesitancy to participate** in civic life something that has always meant a great deal to me

Despite multiple respectful emails and a public offer to meet and resolve this matter constructively, I have received **no response at all** from Councilmember Orbach. This continued silence — alongside the ongoing public defamation — makes it clear that the issue will not resolve itself.

Because of this, I am **copying legal counsel on this message**, not as a threat, but to underscore that this situation now meets the threshold of actionable harm. I have been advised to document and preserve all communication and to explore remedies if the City does not act.

I remain hopeful that the Council will choose to demonstrate leadership and accountability — and that Councilmember Orbach will offer a **public apology** for the harm caused. Without that, the damage will persist — and so will the question of whether this City protects residents from abuse of power.

I am again requesting that the Council take the following actions:

- 1. A formal Resolution of Censure for Councilmember Orbach
- 2. Removal from committee assignments or ceremonial roles until this matter is addressed
- 3. Participation in civility and ethics training as part of restoring public trust
- 4. A clear public apology from the dias by Councilmember Orbach to acknowledge the harm done
- 5. A Council-initiated review of the Code of Conduct enforcement process

Capitola is better than this. We deserve a civic culture where residents can speak, participate, and advocate without fear of public smearing or retaliation from elected officials.

With the next Council meeting scheduled for June 26, and no additional meeting until July 24, I respectfully request that this matter be acknowledged on the public record during the June 26 meeting, and that I receive a written response or update from the City no later than July 3, 2025.

I believe this is a reasonable and necessary step toward transparency, accountability, and restoring trust — and it avoids further delays that could prolong the harm already caused.

Thank you for your time and your attention to this serious matter. I look forward to your response.


