Special Event Background

Police Department issues SE permits

- *Major SE Permits*
 - Over 200 attendees
 - Closure of a major street (as defined by Ordinance 1065)
 - Notable impacts on City services or a neighborhood
- *Minor SE Permits*
 - Between 75 to 200 attendees
 - Not requiring closure of a major street
 - Minimal impacts on city services
 - Can be approved by the City Manager

2025 - Staff Issued 11 Major SE Permits, 20 Minor SE Permits, and 30 City Organized Events

2025 Recap

- Joint debriefs were conducted with event organizers and overall, the events were successful.
 - Continuous request to encourage any new events to occur on “shoulder season”
 - Staff billed for 876 hours of City staff time. City incurred a total of \$111,807 in costs associated with events, 100% reimbursed by organizers.
 - Staff is prepared to support 2026 Major and Minor Events listed in staff agenda report.

Coastal Development Permit

CDP required by City's approved LCP if one or more criteria:

1. Scheduled Memorial Day through Labor Day for more than 2 days, including setup and takedown
 2. Event occupies a portion of a publicly or private beach, park, wharf, or beach parking AND potential for adverse effect on sensitive coastal resources
 3. Fee charged for admission and/or seating where no fee is currently charged OR, if fee is charged for preferred seating and less than 75% of seating is free

Coastal Development Permit

Recurring Events requiring CDP

1. Junior Guards Competition – takes place during summer and involves more than 2 days including setup and takedown.
 2. Capitola Beach Festival – occupies portions of beach and wharf and potential for adverse effect on sensitive coastal resources

Recommended Action

- Provide feedback, specific changes, or direction for recurring Special Events Permits; and approve recurring minor and major special events for 2026.
 - Adopt a resolution to approve Coastal Development Permit #25-0607 for the 2026 Capitola Beach Festival and Junior Guards Competition.
