SUBJECT: Budget Amendments/Transfers

BACKGROUND:

I have received several budget amendments and/or transfer requests. As you know, transfers require only your notification whereas amendments require your approval. Listed below you will find a description of the amendments and/or transfers. I have also attached a copy of the supporting documentation for the appropriations.

Transfers:

Transfer \$600 from account 10-580-014 Environmental Travel to account 10-420-011 Executive Communications to add two new communication lines to allow staff access to Cityworks.

Transfer \$44,177 from the General Fund departmental 004 COLA Pay line items to the 002 Wage line items to implement the budgeted 1.8% increase effective in January.

Transfer \$13,536 from the Utility Fund departmental 004 COLA Pay line items to the 002 Wage line items to implement the budgeted 1.8% increase effective in January.
