

The undersigned further states that he has examined the site of the work and has informed himself fully in regard to all conditions pertaining to the requirements thereof, and that he has gone over and examined the specifications for the work and the contract documents relative thereto and has familiarized himself with all the provisions furnished prior to the opening of bids, and that he has satisfied himself relative to the amount and quality of the type of work to be performed.

Base Bid Scope of work generally consists of the demolition of the Town's One Story 700+/- SF Restroom Facility located at the Boardwalk and construction a new two (2) story 1,600+/- SF restroom located at the same location. Minor sidewalk demolition and replacement will be required for sanitary and utility connections, and an elevated ADA Ramp Connection to the existing boardwalk is proposed to be installed to connect the upper level.


