Urgent Meeting Items

1. Item:

Tom & Sharon Worman have submitted a Conditional Use Permit for PRN 34677, PRN 20625, PRN 34675 & PRN 34676. This would allow them to build a 5-building apartment complex with 256 units.

Discussion:

Member Whitaker expressed that he wanted to make sure it was done correctly and the surrounding neighbors wouldn't be bothered.

Town Manager Forbes said the conditional use permit could be revoked if it was not done correctly.
