### 9. Water and Sewer Tap Increase

Vice-Mayor Bohannon asked if \$1,500 was for water and \$1,500 was for sewer. Town Manager Forbes said yes. He had a display of parts for a larger project with prices on each part for reference. The larger job cost \$3,560 without including labor and rock. Currently we are losing money. Council Member Wilson asked why do we need taps. Town Manager Forbes responded because of new services or rehab of old lines. Vice-Mayor Bohannon asked if we are still losing money at the new suggested rate. Town Manager Forbes suggested charging cost plus \$300 per tap.

Motion to increase water and sewer tap fees by cost plus \$300 made by Council Member Wilson, Seconded by Council Member McCargo.

# **Mayor/Council Comments**

Mayor Fahringer stated that the Fire department would be hosting the rodeo again next year on October 3, 2026. The Fire department also has a stew coming up on November 1, 2025. He appreciates the local support on events here. Volunteerism is needed for lots of different groups, and he encourages people to join. Mayor Fahringer wants the public to know that the Town is aware of the layoffs surrounding the area and is trying to help with the problem.

Vice-Mayor Bohannon commented on how nice the airport looked with the new pavement. The last Fly In will be October 25, 2025.

Council Member Wilson announced that the Trunk or Treat will be at the Pavilion on October 31, 2025. Call Tina Woods at the Chamber to join in.

Council Member Whitaker told everyone to come out and enjoy a free breakfast at the Fly In. He commented on the Fire Department having a stew the 1st Saturday in November. He echoed the Mayor's sentiments on the rodeo growing every year. The Fire Department will be serving hotdogs again this year at the Trunk or Treat.

Council Member Keeton reminded everyone that Election day is November 4, 2025 and you need to exercise your right to vote.
