Council Member Whitaker commented that Shirley Morgan had helped the fire department a lot and will be missed.

### **Town Manager's Oral Report**

Town Manager Forbes said last month he had attended meetings for B Street progress, Dominion Energy & the Chamber of Commerce lunch. He went on to thank the guys for getting Spring Clean-up done this week. Forbes said the Fire Department sewer line repair was not as fast as expected due to the multiple layers of concrete. The Town Manager said at the waste water treatment plant they are still getting a large flow of infiltrate water during large rain events. He is hopeful that the B Street utility repair will help alleviate that problem. He reported that the runway and apron project at the airport is slated to begin July 2024. We were able to install a new windspeed indicator thanks to a grant from the aviation department. He said the Rock Café had their grand reopening. Forbes reported that prep work has started today to for the new town mural. Mr. Forbes finished his report by saying that budgets workshops are being planned for the end of this month or the first of next month.
