Dr. Laura Guyer introduced Frank Catalanotto, DMD, who discussed his presentation on, "Dental Access: facts, fictions and fairy tales." Dr. Catalanotto founded this group and for the past 8 years, across Florida has been advocating for the Dental Therapist model, to provide access to dental care to help with Florida's dental deserts. He indicated that data shows it's the worst in the nation. Dr. Catalanotto referenced literature on evidenced based approaches to improving access to care and Dental Therapist is a good model. This bill has been denied by the legislature. The FDA, "opposed this legislation because Florida has a sufficient dental workforce to address the dental care needs in the state of Florida. Dr. Catalanotto hopes it will pass in this upcoming Florida legislature.

Website Traffic - Key Points

- 5.8k views and 1.7k unique users
- The top-visited page was again the homepage, followed by Bids and RFPs and the Programs Directory.
- Most views are again coming from organic searches, followed by direct access. Organic social media access increased slightly from the last time frame.

Social Media - Key Points

- Gained 21 net followers on Facebook and 9 followers on Instagram (both on par with last month)
- Facebook posts reached 12.4K users (^160%), and Instagram posts reached 958 users (^79%), all organic reach. These were largely boosted by two very popular pieces of content: The announcements for Enrichment (4.6k reach on Facebook) and Belita as Director of Program Operations (4.4k on Facebook)
- LinkedIn had 389 organic impressions and gained 7 new followers. The biggest boost came from the job listing for Executive Assistant (177 impressions and 22 clicks alone).
- Our Constant Contact open rate is a remarkable 41% over the past month, with 3% clickthrough rate. There were 4 net new subscribers.

SUCCESS STORIES

Junior Achievement 3DE Program at Eastside High School

The Junior Achievement - 3DE program got off to a strong start at Eastside High School this Fall. Since kicking off in August, over 250 East Side HS Freshmen have enrolled in the program which integrates real-world experiences with academic learning through partnerships between local school districts, Junior Achievement, and the business community. Through these partnerships, students connect with local business leaders and collaborate in small teams to develop strategies to address real business challenges. Last October 3DE students presented their ideas for strategic partnerships that the Alachua County Sheriff's Office could pursue to impact local problems.

In November with *Campus USA* as the 3DE Case Study partner, the impact of strong partnerships with local business stakeholders was on display at Eastside High School. On November 21, eight *Campus USA* representatives worked with students and teachers for a full day of activity. Due to the number of *Campus USA* "coaches" present and their willingness to engage in a full day of classroom activities, the coaches were able to meet individually with each 3DE team. This provided 3DE student teams with the opportunity to ask questions, gain business insights, and receive coaching and feedback as they develop and refine their ideas into strategies.

The Eastside HS 3DE Student teams will present their business case solutions on December 12, 2024 from 9:30 AM – 11:30 AM. Campus USA will be providing lunch for all of the students for the event and the company's CEO, COO and CFO are serving as the judges for the students' presentations.
