Recommend Board Action: Animal Welfare Group.

Discussion: The Fallon Animal Welfare Group (FAWG) is a non-profit organization formed in 2010 with programs in place to help stop the overpopulation of unwanted cats and kittens. FAWG and its all-volunteer members help tackle a problem in our community that others don't want to deal with. Churchill County has thousands of feral cats, many of which are poisoned, tortured, shot, or drown. FAWG helps stop the overpopulation of unwanted cats and kittens through its programs like the Trap-Neuter-Return (TNR) program to effectively and humanely control the homeless cat population. The TNR program helps use the ability of the cats to get them "jobs" as barn cats.

Unlike other organizations and groups, FAWG operates solely with unpaid volunteers, who donate their time and gas money driving cats/kittens to Carson or Reno for vet visits, fostering kittens, opening their homes, fundraising, helping place barn cats at farms where owners need help with rodent problems, and they offer pet grooming services to assist senior citizens with their pets' needs.

FAWG differs greatly from CAPS no-kill shelter facility for dogs and cats. Although CAPS offers a spayneuter assistance program (SNAP) to help low-income families with the cost of neutering their pets, SNAP does not assist with neutering barn cats, feral cats, or other free-roaming cats. If someone contacts CAPS about feral cats, they provide FAWG's phone number. The two programs complement each other, and together they are helping reduce the number of unwanted litters and homeless animals entering the shelter or being tortured/harmed each year.
