FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR MAN-CAVE STORAGE CONDOMINIUM

THIS FIRST AMENDMENT (this "Amendment") is executed as of this day	of
, 2020, by the Man-Cave Storage Condominium Association, Inc. (the "Association"	"),
pursuant to consents evidencing an affirmative vote of not less than three-fourths (3/4ths) of all votes entitl	led
to be cast by the Unit Owners, as required by the Declaration.	

RECITALS:

- A. A Declaration of Condominium for Man-Cave Storage Condominium was recorded with the Winnebago County Register of Deeds as Document No. 1818522. Said declaration is referred to herein as the "<u>Declaration</u>." Man-Cave Storage Condominium is referred to herein as the "<u>Condominium</u>."
- B. The Units Owners recognize that the Declaration as contemplated by the Declarant is not suitable to the needs of the Unit Owners. They desire to amend the Declaration such that each Unit Owner has more individual freedom and responsibility with respect to their Unit.
- C. Section 21 of the Declaration provides that the Declaration may, generally and as applicable to the amendments made herein, be amended upon the affirmative vote of no less than three-fourths (3/4ths)

of all votes entitled to be cast by the Unit Owners, provided that the affirmative vote must be approved by the mortgagee with respect to those Unit Owners.

D. The required written consents and approvals for this Amendment have been received, as evidenced herein.

NOW, THEREFORE, the Association and the Unit Owners do hereby declare as follows:

1. Authorized and Restricted Uses of Property. Section 9(a) is hereby deleted and the following is inserted:

"Each of the Units shall be occupied and used only for personal workshop use, storage purposes, and/or trade or non-retail business purposes only, and for no other purposes all such uses being subject to Section 9(k) of the Declaration. No retail business or use of residence-like activity shall be carried out anywhere within the condominium, except as otherwise provided herein."

To the extent that any provision in this Amendment conflicts with the Declaration, this Amendment shall control.
