We, the undersigned, maintain that the 1 mile stretch of Clayton Avenue from Larsen Road to Winchester Road (County Highway II) has become increasingly **hazardous** over the past several years to area residents who live directly on Clayton Avenue or off a side street that intersects with Clayton Avenue, as well as anyone else who may travel Clayton Avenue, and to the pedestrians and bicyclists who traverse Clayton Avenue between trails, **due to** a number of reasons including but not limited to:

1. High vehicle speeds, many faster than the posted 45 MPH, especially notable after the opening of the Neenah High School nearby.
2. Greatly increased traffic volume overall, dangerous passing zones, narrow shoulder, steep ditches, and narrow roadway.
3. Aggressive driver behavior, refusal to slow down or move over while passing pedestrians and bicyclists, and tailgating.

Now therefore we the undersigned:

1. **Call upon** the Town of Clayton and the Town of Neenah to enact an Ordinance to reduce the speed limit on Clayton Avenue from 45 MPH to a safe speed (30-35MPH).
2. **Call upon** the Town of Clayton and the Town of Neenah to cooperate as may be required to install Traffic Monitoring / "Your Speed" signs installed in both directions on Clayton Avenue.
3. **Call upon** the Winnebago County Sheriff's Department to commit to increased ongoing speed limit enforcement on Clayton Avenue.
