WHAT IS BEING ASKED OF THE CITY COUNCIL/BOARD:

The City Council is being asked to adopt resolution 2024-06 Amending the FY 2023-24 Budget to include Mid-Year Adjustments.

BACKGROUND/DISCUSSION: Staff has completed a mid-year review of the FY 2023-24 budget.

Overall, revenues are coming in as anticipated or slightly lower. City departments are adjusting budgets, reducing costs and recognizing savings when possible to keep the budget on track. Based on a review of revenue and expenditures to date, and in consultation with department heads, below is a list of mid-year adjustments proposed for consideration by the City Council:

Department	Description	Amount	
Admin Svcs	Transferring Fund Balance from Fund 106 - Visitor Center Project to General Fund Building Maintenance for Visitor Center. Funds will be used for water closure and building repairs.	\$ 3,955	
City Manager\Public Works	Development Impact Fees approved by Council will be moved to Capital Projects for the Airport Rd Project and expensed from there.	\$528,443	
Finance	The City has transitioned management of Transient Occupancy Tax and Tourism District Assessment, from HDL to the finance department, using our OpenGov reporting platform. A budget has been created for Revenue received and expensed out to the Lake County Tourism Improvement District.	\$30,000	
Police Department	Anticipated revenue is an insurance payout with expenditure appropriations for a leased vehicle replacement.	\$52,788	
Recreation	Recognizing revenue for department coordinator scholarship and expense to attend training conference.	\$500
