

1 **SECOND AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF CLEARLAKE, CITY OF**
2 **LAKEPORT AND COUNTY OF LAKE FOR OPERATION OF A LOCAL PUBLIC,**
3 **EDUCATIONAL, GOVERNMENTAL (PEG) CABLE TELEVISION CHANNEL**

4 THIS AMENDMENT is entered into this _____ day of _____, 2023, by and between the
5 City of Clearlake, City of Lakeport and County of Lake, for operation of a local public, educational,
6 governmental cable television channel, hereinafter referred to as Lake County PEG TV.

7 **WITNESSETH**

8 **WHEREAS**, in July of 2019, the City of Clearlake, City of Lakeport and County of Lake entered into a
9 written Agreement to continue the operation, maintenance and funding of Lake County PEG TV, in the
10 best interest of the citizens of Lake County, with said Agreement to expire June 30, 2021; and

11 **WHEREAS**, that Agreement envisioned extension of the "Term of Agreement," in two-year increments,
12 as found to be desirable and appropriate by the parties thereto and the Lake County PEG TV Board of
13 Directors.

14 **WHEREAS**, all parties previously acted to extend the Term of this Agreement through June 30, 2023,
15 with the First Amendment to the 2019 Agreement.

16 **WHEREAS**, all parties wish to continue their participation through at least June 30, 2025.

17 **NOW, THEREFORE**, the parties hereto agree as follows:

- 18 1. That Section 5. of the original 2019 agreement is hereby amended as follows:

19 This Agreement shall begin on the date of execution by all parties to this Agreement and shall
20 continue in full force and effect until June 30, 2025, unless terminated as hereinafter provided.

21 By March 1, 2025, the City Managers of each City and the County Administrative Officer shall
22 meet to discuss the extension of this Agreement.

23 Except as specifically modified herein, all other terms and conditions of the July 16, 2019 Agreement
24 shall remain in full force and effect.
