### WHAT IS BEING ASKED OF THE CITY COUNCIL/BOARD:

The City Council is being asked to accept and approve the contract for the Austin Beach Water Project.

**BACKGROUND/DISCUSSION:** On December 16, 2021, Council approved staff to apply for the grant through the State Department of Parks and Recreation. The city was approved the for the grant funding up to \$177,952.00.

The approved application was submitted for the Austin Beach Water Project. This project will consist of the installation of an aquatic bubble curtain in the water at the Austin Beach location. Staff sent out an RFP and the lowest proposal was \$185,060.88. Staff has collaborated with Clean Lakes, Inc. for a proposal that will fall within the allotted grant funding, The new amount is \$148,603.80. If approved, this project will help create cleaner and safer water in the designated area. This will enable residents to enjoy the water for a longer period each year.

If accepted, staff will move forward with the contract with Clean Lakes Inc.
