

**RESOLUTION 2026-07**  
**A RESOLUTION ADOPTING**  
**THE MASTER FEE SCHEDULE**  
**FOR THE CITY OF CLEVELAND, GA**

**WHEREAS**, the City of Cleveland has adopted a Code of Ordinances that authorizes the assessment and collection of fees, fines, charges, permit costs, license fees, administrative costs, penalties, and other monetary amounts; and

**WHEREAS**, Ordinance No. 11111 adopted and enacted a new Code of Ordinances for the City of Cleveland, Georgia, repealing and replacing the former Code in its entirety, and provides that such fees, fines, charges, permit costs, license fees, penalties, and other monetary amounts shall be established and amended from time to time by the Mayor and Council through a fee schedule maintained separately from the Code of Ordinances; and

**WHEREAS**, the Mayor and Council find that maintaining a consolidated Master Fee Schedule promotes efficient administration, transparency, public accessibility, fiscal responsibility, and the ability to adjust fees through public action without requiring amendment of the Code of Ordinances;

**WHEREAS**, the Mayor and Council find that establishing such amounts in a separate fee schedule promotes efficient administration, transparency, fiscal responsibility, and public accessibility; and

**WHEREAS**, concerns remain regarding the long-term health effects of vaping, exposure to chemicals contained in vaping products, and the potential for flavored products to increase youth access and use; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Cleveland, Georgia, that the City of Cleveland Master Fee Schedule, attached hereto as Exhibit A, is hereby adopted and shall serve as the official schedule of fees, fines, charges, rates, permit costs, license fees, administrative fees, penalties, service charges, and other monetary amounts authorized by the City Code, state law, or other duly adopted ordinances, resolutions, or regulations.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City shall make the Fee Schedule available on the City's official website and the City Clerk shall maintain the current Fee Schedule and all amendments thereto for public inspection during normal business hours at City Hall.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that this Resolution shall become effective immediately upon its adoption by the Mayor and Council.

**BE IT FURTHER RESOLVED** that if any section, subsection, sentence, clause, phrase, fee, charge, rate, or provision of this Resolution or the Fee Schedule attached as Exhibit A is determined by a court of competent jurisdiction to be invalid or unenforceable, such determination shall not affect the validity or enforceability of the remaining portions of this Resolution or Fee Schedule, which shall remain in full force and effect.
