Subject:	Authorize the Façade Improvement Grant Program Award Recommendations in the Amount of \$553,000 and Authorize the City Manager to Execute Grant Agreements with Property Owners Participating in the Program		

STAFF RECOMMENDATION:

Staff recommends that the City Council considers authorizing the Façade Improvement Grant Program award recommendations in the amount of \$530,000 and authorize the City Manager to execute Grant Agreements with the property owners participating in the program.

BACKGROUND:

The Commercial Façade Improvement Grant Program ("Program") is an endeavor of the City of Coachella to leverage public funds and private investment to enhance the physical appearance and economic vitality of commercial businesses in the Downtown Pueblo Viejo Area and the segments of Cesar Chavez Street between Sixth Street and Avenue 52 and Sixth Street between Cesar Chavez Street and Grapefruit Boulevard. The long-term objective is to upgrade the Downtown Pueblo Viejo Area by improving the physical appearance of the area, encouraging the retention of existing businesses, increasing property values, tenant stability, and lease rates for the properties.

DISCUSSION/ANALYSIS:

The program received eight (8) applications from property owners requesting a total of \$553,000 in this round. The program has a few more applicants who will submit their applications in the coming weeks.
