

**NOTICE INVITING BIDS**

NOTICE IS HEREBY GIVEN that the City of Coachella, a municipal corporation, organized under the laws of the State of California, with its principal place of business at 53462 Enterprise Way, Coachella, California 92236 ("City") invites and will receive sealed Bids up to but not later than 3:00 P.M. on Tuesday, 11/26/2024, at the City Offices, located at 53462 Enterprise Way, Coachella, California 92236, for the furnishing to City of all labor, equipment, materials, tools, services, transportation, permits, utilities, and all other items necessary for **Headworks Screening System Improvements, City Project No. S-29** (the "Project"). At said time, Bids will be publicly opened and read aloud. Bids received after said time shall be returned unopened. Bids shall be valid for a period of 90 calendar days after the Bid opening date.

The project consists of the procurement and installation of a new screenings device, screenings conveyor, washer compactor, control panel with controls for both the new screening device and the existing screening device as well as other associated Site Civil, Yard Piping, Mechanical, Electrical, and I&C components as described in the Contract Documents, and all associated work for a fully functional project. All work to be constructed and performed in a workmanlike, professional manner, and to the satisfaction of the City. The full project shall be completed within **503 Working Days** from the date specified in the Notice to Proceed. Time for the commencement and completion of the work is important and is to be of the essence of the Contract. The successful bidder should plan to provide Preliminary Project Schedules, Traffic Control Plans, and other specified "Submittals" for review, and order any long lead time equipment items immediately following the "Notice of Award".
