

**CITY OF COACHELLA  
RESOLUTION NO. 2026-24**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA  
AUTHORIZING THE DESIGNATED AGENTS OF THE CITY OF COACHELLA TO  
PROVIDE TO THE GOVERNOR’S OFFICE OF EMERGENCY SERVICES (Cal OES)  
FOR ALL MATTERS PERTAINING TO SUCH STATE DISASTER ASSISTANCE THE  
ASSURANCES AND AGREEMENTS REQUIRED**

**WHEREAS**, the City of Coachella (hereinafter referred to as the “Applicant”) is a public entity established under the laws of the State of California; and

**WHEREAS**, the Applicant is eligible to receive State and Federal disaster assistance funding administered by the California Governor’s Office of Emergency Services (Cal OES); and

**WHEREAS**, Cal OES requires the Applicant to designate authorized agents to execute documents and provide assurances and agreements necessary to obtain such assistance;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COACHELLA AS FOLLOWS:**

**Section 1. Designation of Authorized Agents**

The following positions are hereby authorized to execute for and on behalf of the City of Coachella, a public entity established under the laws of the State of California, applications for State and Federal disaster assistance and to file such applications with the California Governor’s Office of Emergency Services (Cal OES) for the purpose of obtaining financial assistance for any existing or future grant program: City Manager, Director of Economic Development, and Grants Manager.

**Section 2. Authority Granted**

The City of Coachella hereby authorizes the above-designated agents to provide to the California Governor’s Office of Emergency Services (Cal OES), for all matters pertaining to such State and Federal disaster assistance, the assurances and agreements required.

**Section 3. Term of Authorization**

This resolution shall be a universal resolution and shall remain in effect for all open and future disasters/grants.

**Section 4. Supersession**

This resolution supersedes all prior resolutions pertaining to the designation of authorized agents for Cal OES disaster assistance.

**Section 5. Attachment Incorporation**

The City Council hereby approves and incorporates by reference the “Designation of Applicant’s Agent Resolution for Non-State Agencies (Cal OES Form 130)”, attached hereto as Attachment 1-Cal OES 130, and authorizes its execution.
