

RESOLUTION NO. 2025-35

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT AGREEMENT WITH IMPERIAL IRRIGATION DISTRICT IN THE AMOUNT OF \$29,600 FOR THE PUBLIC GREEN SPACE GRANT BAGDOUMA PARK PROJECT

WHEREAS, Imperial Irrigation District's (IID) 2025 Public Green Space Grant Program initiative is part of IID's Tree for All program; and

WHEREAS, The Public Green Space Grant Program aims to reduce urban heat, lower temperatures, and beautify local neighborhoods through tree planting; and

WHEREAS, the City of Coachella submitted a grant application to the Public Green Space Grant Program to support its Bagdouma Park tree planting project; and

WHEREAS, IID approved a grant award on June 5, 2025, in the amount of Twenty-Nine Thousand, Six Hundred Dollars (\$29,600) to the City of Coachella for the implementation of the proposed project; and

WHEREAS, the acceptance of this grant will enable the City to advance its efforts to increase its tree canopy, expand green spaces, and enhance its parks.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, AS FOLLOWS:

SECTION 1: The City Manager is hereby authorized to execute a grant agreement for Grant funds for the purpose of obtaining financial assistance provided by Imperial Irrigation District.

SECTION 2: The City of Coachella hereby agrees to comply with each and all of the terms, conditions, and limitations imposed by the Grantor upon said Grant, and the City Manager is hereby authorized and directed to execute any agreements, assurance, extensions, amendments or other documents as may be necessary in connection with acceptance and implementation of said Grant as may be required by the Grantor.
