

**RESOLUTION NO. 2025-59**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA ADOPTING A NEW SELF-EVALUATION AND TRANSITION PLAN TO CREATE ACCESSIBLE POLICIES, PROCEDURES, PROGRAMS, AND FACILITIES FOR RESIDENTS WITH DISABILITIES IN THE CITY OF COACHELLA.**

**WHEREAS;** the City of Coachella, under Title II Subpart A of the Americans with Disabilities Act (ADA), must enact a Self-Evaluation and Transition Plan to remove barriers to residents with disabilities, both physical, policy, and programmatic; and,

**WHEREAS,** the City of Coachella must evaluate services, policies, practices, and physical accessibility for people with disabilities; and,

**WHEREAS;** the City of Coachella must identify modifications needed to services, policies, practices, and facilities; and,

**WHEREAS;** the City of Coachella does not have comprehensive self-evaluation and transition plan addressing accessibility for people with disabilities; and,

**WHEREAS;** Title 28 Chapter I Subpart A of the Code of Federal Regulations prohibits public entities from discrimination on the basis of disability; and,

**WHEREAS;** the City of Coachella must comply with the requirements of the ADA; and,

**WHEREAS;** the City of Coachella must make continuous improvements of City programs for people with disabilities; and,

**WHEREAS;** the City of Coachella must enable residents with disabilities to participate equally in the City's programs, services, and activities; and,

**WHEREAS;** accessibility applies to all aspects of programs or services provided by the City.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COACHELLA DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1: Adoption of the Coachella Self-Evaluation and Transition Plan.** The City Council hereby adopts the Plan to create accessible policies, programs, procedures, and facilities set forth in the document, called “City of Coachella ADA Self-Evaluation and Transition Plan”, attached hereto, to define appropriate implementation prioritization of accessible policies, procedures, programs, and facility renovations.
