ORDINANCE NO. 1194

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COACHELLA ACTING AS THE LEGISLATIVE BODY OF CITY OF COACHELLA COMMUNITY FACILITIES DISTRICT NO. 2005-1 (LAW ENFORCEMENT, FIRE AND PARAMEDIC SERVICES) AUTHORIZING THE LEVY OF A SPECIAL TAX WITHIN ANNEXATION AREA NO. 33 ANNEXED TO SAID DISTRICT

WHEREAS, on April 13, 2022, the City Council (the "Council") of the City of Coachella, California (the "City"), adopted Resolution No. 2022-38 stating its intention to annex certain properties, consisting of Mariposa Pointe – Tract No. 32074, 32074-1 and 32074-2 ("Annexation Area No. 33"), into City of Coachella Community Facilities District No. 2005-1 (Law Enforcement, Fire and Paramedic Services) (the "District") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act"); and

WHEREAS, notice was published as required by law relative to the intention of the Council to annex Annexation Area No. 33 into the District; and

WHEREAS, on June 8, 2022 this Council held a noticed public hearing as required by law relative to the determination to proceed with the annexation of Annexation Area No. 33 into the District and the rate and method of apportionment and manner of collection of the special tax to be levied within Annexation Area No. 33 to finance certain public services; and

WHEREAS, at said hearing all persons desiring to be heard on all matters pertaining to the annexation of Annexation Area No. 33 were heard and a full and fair hearing was held; and

WHEREAS, the Council subsequent to said hearing adopted Resolution No. 2022-50 determining the validity of prior proceedings relative to the annexation of Annexation Area No. 33, annexed Annexation Area Nos. 33, into the District and authorized the levy of a special tax within Annexation Area No. 33; and

WHEREAS, the Council subsequent to said hearing adopted Resolution No. 2022-51 which called an election within Annexation Area No. 33, for June 8, 2022 on the proposition of levying a special tax; and

WHEREAS, on June 8, 2022 an election was held within Annexation Area No. 33, in which the eligible electors approved by more than two-thirds vote the proposition of levying a special tax;

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF COACHELLA AS FOLLOWS:

<u>Section 1.</u> A special tax is levied within the boundaries of Annexation Area No. 33 (Exhibit B), pursuant to the formula set forth in Exhibit "A" attached hereto and incorporated by reference in an amount necessary to finance a portion of the cost of providing law enforcement,

fire and paramedic services that are in addition to those provided in the territory within Annexation Area No. 33 prior to the annexation of Annexation Area Nos. 33, respectively, into the District.

Section 2. This legislative body is hereby further authorized each year, by resolution adopted as provided in section 53340 of the Act, to determine the specific special tax rate and amount to be levied for the next fiscal year, except that the special tax rate to be levied shall not exceed the maximum rate set forth in Exhibit "A."

Section 3. All of the collections of the special tax shall be used as provided for in the Act and Resolution No. 2022-50 of the Council.

Section 4. The above authorized special tax shall be collected in the same manner as ordinary ad valorem taxes are collected and shall be subject to the same penalties and the same procedure and sale in cases of delinquency and provided for ad valorem taxes.

Section 5. The Mayor shall sign this ordinance and the City Clerk shall attest to such signature. The City Clerk is directed to cause the title and summary or text of the this ordinance, together with the vote thereon, to be published within fifteen (15) days after its passage at least once in a newspaper of general circulation published and circulated within the territorial jurisdiction of the City, and to post at the main office of the City a certified copy of the full text of the adopted ordinance along with the names of the Council Members voting for and against the ordinance.

Section 6. This ordinance relating to the levy of the special tax takes effect and shall be in force from and after 30 days from the date of final passage. A copy of this ordinance shall be transmitted to the Clerk of the Board of Supervisors of Riverside County, the Assessor and the Treasurer-Tax Collector of Riverside County.
