#### Library Program Spring 2025

Palm Springs Art Museum hosts Family+ monthly on every third Sunday of the month where we welcome community members to participate in various workshops and activities led by local and regional artists. Family+ is free to attend and includes museum admission. Community members are invited to explore the museums permanent collection and special exhibitions, create art, and explore a new medium.

In previous years Palm Springs Art Museum partnered with local libraries to provide art boxes for community members to try new art activities with their families and introduce them to museum events and invite them to monthly Family+ program. In 2024 the museum hosted *Art in the Library* where 3 local artists hosted workshops of varying mediums at three libraries. This year, we partnered with the same libraries as the previous year with the exception of Mecca Library who is currently under renovations. Cathedral City Library partnered with the museum in place of Mecca Library.

Art in the Library was hosted this spring to invite community members to our Family+ on June 15, 2025, at Palm Springs Art Museum.

Palm Springs Art Museum recognizes its role as a community hub to engage, include, and welcome community members of the Coachella Valley and visiting neighbors. Every third Sunday of the month the museum hosts Family+ where we welcome community members from 12pm-4pm for various workshops and activities led by local and regional artists. Family+ is free for everyone and includes museum admission for the day. Community members are invited to create art, explore a new medium, and engage with the museum's art collection. Through intentional strategizing to engage communities who face geographic and transportation barriers when looking to visit the museum we took art workshops out of the museum and brought them to various community libraries.

Palm Springs Art Museum is partnering with libraries across the Coachella Valley to build connections between communities and museum programming. Through the library

program, we build relationships by hosting local artist workshops where community members can join free of charge. The structure of these workshops mimics our Family+ event that takes place in the museum every third Sunday of the month where families join us for workshops and activities. The largest barrier for families looking to visit the museum or attend a public program is transportation, which is why the museum is meeting community members in their cities of residence.
