

**AMENDMENT NUMBER TWO
to the
TWO-PROJECT AGREEMENT WITH THE CITY OF COACHELLA TO PROVIDE REGIONAL
FUNDS FOR PLANS, SPECIFICATIONS AND ESTIMATES AND RIGHT-OF-WAY
ACTIVITIES FOR A NEW BRIDGE OVER THE COACHELLA VALLEY STORMWATER
CHANNEL ONLY ON AVENUE 50**

This **AMENDMENT NUMBER TWO** is made and entered into this 28th day of April, 2025, by and between the **Coachella Valley Association of Governments**, a California joint powers agency (**CVAG**), and **the City of Coachella** (Agency), and is made with reference to the following background facts and circumstances. All other terms and conditions shall remain the same as stated in the original Agreement for a New Bridge Over the Coachella Valley Stormwater Channel and a New Interchange at State Route 86, both on Avenue 50.

The Engineering Design and Environmental Document work is completed for the two projects. Amendment Number One provided additional funding for the Avenue 50 Bridge Over the Coachella Valley Stormwater Channel to complete plans, specifications and estimates (PS&E) and right-of-way (R/W). This Amendment Number Two authorizes CVAG to provide additional funding for the New Interchange at State Route 86 on Avenue 50 and include improvements to an additional segment of Avenue 50 between Oates Lane and Cabazon Drive Project, increasing the Regional Arterial Program Funding Contribution from \$5,535,626 to \$10,910,626, an increase of \$5,375,000 to provide shovel ready plans, specifications and estimates (PS&E) and right-of-way (R/W). This amendment will also extend the time trigger for construction to July 1, 2029.

This amendment provides for the City to reimburse CVAG for deferred design costs should construction not go forward by the time trigger.

This amendment adds \$5,000,000 to the Interchange at State Route 86 on Avenue 50. For this project, the City's reimbursement to CVAG of the additional \$1,250,000 in regional funding will be deferred until the project construction phase. The regional contribution for the segment on Avenue 50 between Oates Lane and Cabazon Drive is \$375,000, and City share is \$125,000.



Subject: Request for Amendment #2 for a New Interchange at State Route 86 on Avenue 50 Project and Avenue 50 between Oates Lane and Cabazon Drive Project

Dear Mr. Hoy,

The City of Coachella respectfully requests the Coachella Valley Association of Governments (CVAG) approve Amendment No. 2 to the Agency Reimbursement Agreement between the City of Coachella and CVAG for the New Interchange at State Route 86 on Avenue 50 Project # B-402 and Avenue 50 between Oates Lane and Cabazon Drive Project # B-401 increasing the Regional Arterial Program Funding Contribution from \$5,535,626 to \$10,910,626, an increase of \$5,375,000. It also requests Amendment No. 2 extend the time trigger for construction to July 1, 2029. This amendment would be for phase 2 of the two-project agreement and an additional segment of Avenue 50 between Oates Lane and Cabazon Drive (Project 3) for shovel ready plans, specifications and estimates (PS&E) and right-of-way (R/W).

Avenue 50 is classified as a primary arterial with bicycle facilities per the Mobility Element of the City's General Plan. Avenue 50 between Oates Lane and Cabazon Drive is currently a 2 lane road. The proposed roadway segment will have two lanes in each direction and include pedestrian and bicycle facilities on the southside of Avenue 50 within City right-of-way. The project is adjacent to project B-402 (Phase 1) that includes a new 4-lane bridge over the Whitewater Channel scheduled to begin construction in FY 25/26. With the new alignment on Avenue 50 the City is coordinating construction of this segment to complete the gap between phase 1 of B-401 and B-402 at the same time.

This Proposed Amendment Request would add \$5,000,000 to phase 2 and \$375,000 to the segment on Avenue 50 between Oates Lane and Cabazon Drive.

The increased project costs for this amendment will provide shovel ready plans, specifications and estimates and right-of-way for phase 2 and project 3 of Avenue 50. The PA&ED phase has been completed for phases 1 & 2, including CEQA and NEPA documents. The City has been awarded HBP funds for the phase 1 portion of the project and has been seeking federal and state funds for phase 2, including Nationally Significant Federal Lands and Tribal Projects Program (NSFLTP), Trade Corridor Enhancement Program (TCEP) and Better Utilizing Investments to Leverage Development (BUILD) grant applications. The City recognizes a shovel ready project with a complete PS&E package will be more competitive and successful in these efforts. The City respectfully requests CVAG provide the full \$5,000,000 for phase 2 PS&E and R/W at this time City's 25% match (\$1,250,000) for phase 2 will be paid during the construction phase by reducing the CVAG construction match by the corresponding \$1,250,000 during that phase. City requests the standard 75%/25% split for the project 3 Oates Lane to Cabazon Drive PS&E and R/W which has a total estimated cost of \$500,000 (\$375,000-CVAG / \$125,000-City).

The City of Coachella appreciates CVAG's consideration of increasing the Regional Arterial Program funding contribution toward the proposed New Interchange at State Route 86 and between Oates Lane and Cabazon Drive on Avenue 50.






