SUBJECT: Adopt Resolution No. 2025-24 Amending the "City of Coachella City Council

Policies, Rules, and Procedures" Pertaining to the Order of Business and Public

Comments on Non-Agenda Items

RECOMMENDED ACTION:

Staff recommends that the City Council adopt Resolution No. 2025-24, which changes the order of business for City Council meetings by having public comments on non-agenda items occur prior to the consent calendar.

BACKGROUND:

In May 2019, the City Council adopted Resolution No. 2019-34, which amended the order of business at Council meetings and placed public comment for non-agenda matters to be heard after the public hearing calendar at Agenda Item No. 15. In the event a City Council meeting extended beyond 8:00 p.m., the time for public comment on non-agenda items would be moved up and become the next agenda item.

At the Council meeting on April 23, 2025, Council directed staff to amend the order of business and timing of the public comment period for non-agenda items to occur before the consent calendar for a period of time of up to 30 minutes. If any additional time is required for public comment on non- agenda items, this will occur immediately after the public hearing calendar as is currently the case.

This update to the order of business will promote greater accessibility and public participation and allow members of the public wishing to speak on matters not listed on the agenda to avoid extended wait times before being given the opportunity to address the City Council.
