SUMMARY AND REQUESTED COUNCIL ACTION

Consider appoint James Bell to the Historic Preservation Commission.

Suggested Motion

If approved under the consent agenda, the Council recommends that Mayor Bell appoint James Bell to the Historic Preservation Commission to fill a vacancy on a three year term through March, 2027.

I move to, recommend that Mayor Bell appoint James Bell to the Historic Preservation Commission to fill a vacancy on a three year term through March, 2027.

BACKGROUND

This committee was formed in 1979. It is currently operating under Ordinance A-226 and the Coburg Comprehensive Plan. Council established this committee as an advisory body to the Planning Commission (except for the provisions listed in Ordinance A-226 under Section 5).

The purpose of this committee is to identify, recognize, and preserve significant properties related to the community's history; encourage the rehabilitation and ongoing viability of historic buildings and structures; strengthen public support for historic preservation efforts within the community; foster civic pride; and encourage cultural heritage tourism. The Council has assigned specific duties to this committee, as listed in Ordinance A-226, Section 6.

The committee membership requires three, but no more than five, members who demonstrate competence, knowledge, or interest in historic preservation, with preference given to those with professional experience in preservation, architecture, archaeology, community history, building trades, real estate, or related specialties.

The Heritage Committee voted at its October 8, 2025, meeting to recommend to the City Council, the appointment of James Bell.



RECOMMENDATION

Staff recommend the appointment of James Bell.

This committee was formed in 1979. It is currently operating under Ordinance A-226 and the Coburg Comprehensive Plan. Council established this committee as an advisory body to the Planning Commission (except for provisions listed in the Ordinance A-226 under Section 5.)

The purpose of this committee is to identify, recognize, and preserve significant properties related to the community's history; encourage the rehabilitation and ongoing viability of historic buildings and structures; strengthen public support for historic preservation efforts within the community; foster civic pride; and encourage cultural heritage tourism. The Council has assigned specific duties to this committee, as listed in Ordinance A-226, Section 6.

Meetings: Meets four to six times per year.

Membership Requirements:

Three but no more than five members with a demonstrated competence, knowledge, or interest in historic preservation, with preference given to those with professional experience in the fields of preservation, architecture, archaeology, community history, building trades, real estate, or related specialties. At least two members shall consist of one Planning Commissioner and one resident of the City of Coburg. In cases where there is not sufficient interest or it is difficult to find qualified members, it is acceptable to select commissioners from outside the City of Coburg. Members shall serve without compensation, but are eligible for reimbursement of expenses related to their service. At least one member of the Commission shall reside within the Coburg Historic District.
